# Leicestershire County Council, working with the governing body of Greenfield Primary School, is proposing to:

- Close Countesthorpe Nursery School on The Drive, Countesthorpe; and
- For that provision to be replaced by a new purpose built facility at Greenfield Primary School, to open in September 2017, which will operate as a Governor run pre-school.

#### Introduction

Countesthorpe Nursery ("the nursery") is located on The Drive, Countesthorpe and occupies a Grade II listed building alongside large residential properties.

The nursery is designated as a maintained establishment, which means funding and oversight of the service is through the local authority. On a day to day basis, the nursery is run by an Executive Head Teacher and Governors, who also undertake those same roles at Greenfield Primary School, Countesthorpe, which is a large 630 place, maintained school located nearby.

There are currently 30 nursery places at Countesthorpe Nursery.

#### What are we consulting on?

The County Council, working with the Governing Body of Greenfield Primary School, is proposing to:

- Close the current nursery provision at The Drive, Countesthorpe;
- Construct a purpose built facility at Greenfield Primary School to open in September 2017; and operate as a governor run pre-school. The new facilities will replace and expand the provision currently available at the nursery;
- Support Greenfield Primary School to establish a Governor run pre-school using those new facilities to replace and expand the provision currently available at the nursery.

#### Why change?

The number of children attending the nursery has risen in the last two years. At present there are sufficient places at the nursery to meet Free Early Education Entitlement (FEEE) places of 15 hours per week. However, from September 2017 the Government intends to increase FEEE to 30 hours per week for eligible children. This will place greater demands on the need for space within the nursery. There are also new housing developments in the area that will bring additional demand for nursery places in future years. The council has a responsibility to ensure there are sufficient childcare places available in the area.

The current building is Grade II listed, meaning it is not suitable for further expansion and requires significant maintenance. Additionally, recent changes and works at the neighbouring high and upper school have restricted access to the nursery, causing concerns about road safety and traffic issues.

This proposal is to close the nursery and for that provision to be replaced by a governor run pre-school which will be located in a new, larger, purpose built facility at Greenfield Primary School. Funded through the council's capital programme, the new facility will be bright, modern and flexible, ensuring compliance with disability access requirements and offering greater capacity for more childcare places.

The Head Teacher, Governing Body and staff at the nursery are keen to improve the provision available and the council is supporting the implementation of this scheme. All parties involved see this as a positive step towards safeguarding the future of the provision within the area.

Further, the council considers that this is the most cost effective way of increasing the availability of childcare provision within the area and of maintaining the quality and standards of the existing provision, particularly given the crossover of management personnel between the nursery and Greenfield Primary School.



### The proposals in detail

The plan provided below indicates the existing location of the nursery in relation to Greenfield Primary School the distance between the two is approximately one mile.



It is proposed that the new provision will open as a governor run pre-school and not as a nursery school maintained by the council.

To achieve this the existing Countesthorpe Nursery which is currently maintained by the local authority (this means that the council is responsible for the running and maintenance of the nursery) would close, subject to the outcome of the consultation, and be replaced by a governor run pre-school which will be located in a new, larger, purpose built facility at Greenfield Primary School.

The council would no longer have any responsibilities in the running of the nursery. Greenfield Primary School would be responsible for the running of its new pre-school provision. The new provision would be offer space for 45 nursery places to meet the demands of new housing and government changes to FEEE.

Co-location of the nursery provision with the primary school would ensure better transition into school and better progression in terms of children starting their schooling.

The quality of education, care and learning currently provided by the nursery would be preserved in the new provision as the existing staff and ethos are proposed to transfer.

The nursery would close once the new facility is ready for use. It is intended this would happen in order for the new provision to be in place for the start of the 2017 - 2018 academic year.



### How will the proposals impact my child's nursery provision?

If your child currently attends the nursery, it is proposed that you will be able to request they transfer to the new provision at Greenfield Primary School without the need to apply for a place.

In addition to FEEE hours, further childcare may be available, at additional cost to the parent/carer.

If you are applying for the first time for a place for your child at the nursery from September 2017 then you will be able to apply to the new provision directly in accordance with their admission arrangements.

#### How will the consultation work?

The consultation will take place in line with the 'Statutory Guidance relating to Opening and Closing Maintained Schools' published by the Department for Education in April 2016.

#### What happens next?

Following the informal pre-consultation period the council will consider all responses received and will make a decision on the publication of a 'Statutory Notice' to progress the proposals.

Following publication of the Statutory Notice there would be a period of four weeks for parents/carers and any other members of the public to make representations to inform a decision by the council as to whether to proceed or not with the proposals.

If the proposals are agreed they would be implemented by the council so that new arrangements can be in place for September 2017.
