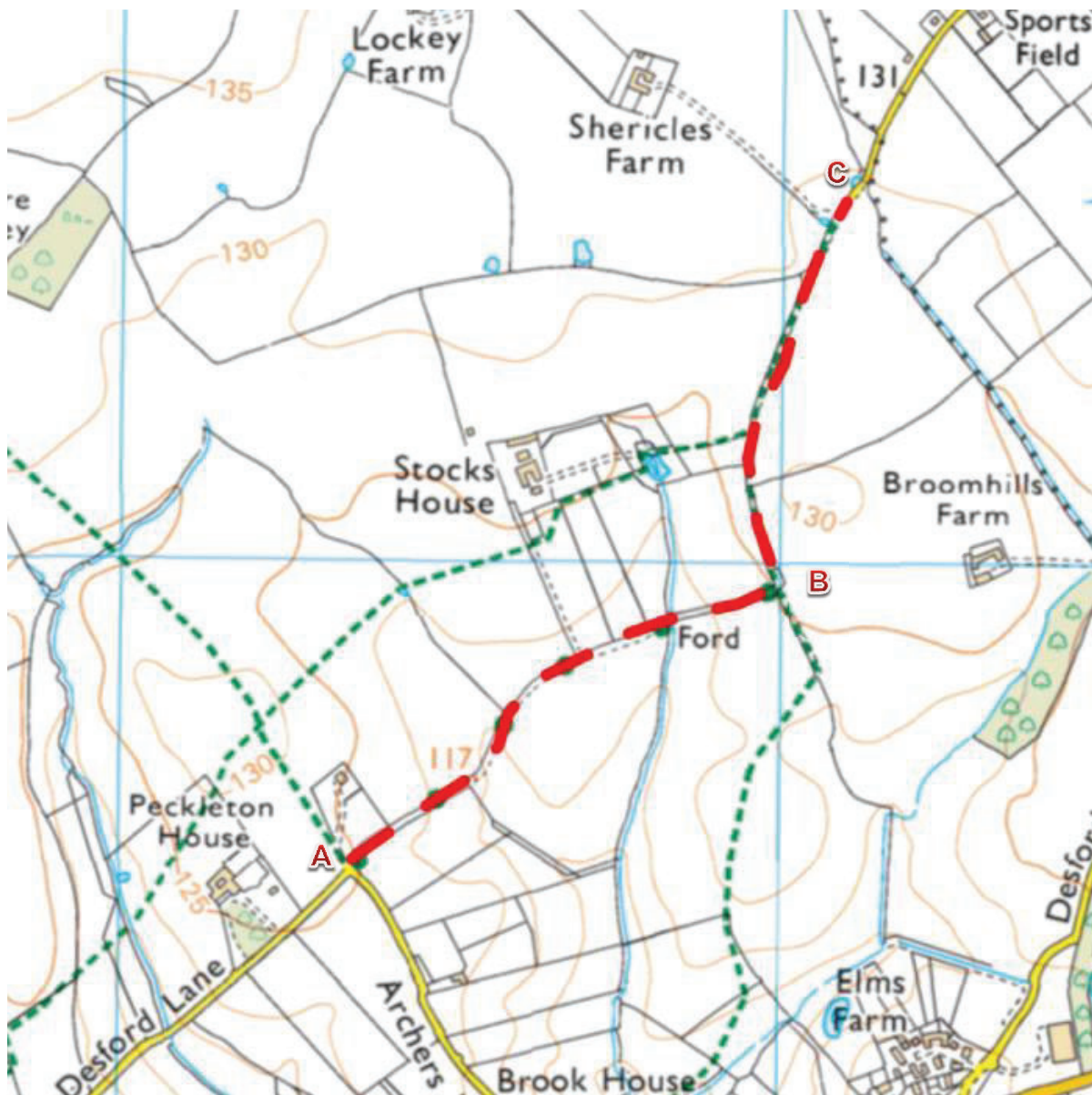

# Wildlife and Countryside Act 1981 Summary of Evidence

## Definitive Map Modification Order Application

**Parish:** Peckleton **Grid Reference:** SK468019

**Map of Path:** Route applied for is shown in RED DASHES starting at the junction of Desford Lane and Archers Lane, going north east along what is known locally as Desford Field Land and ends at the south end of Kirkby Lane near the turning for Shericles Farm. The route is shown as an ORPA on a track leading to a ford then footpath T70 on OS Maps and the online Definitive Map. The route is on the list of streets as Desford Field Lane with mixed maintenance responsibilities. The application is for a BOAT from A to B and a bridleway which may have higher rights from B to C.
