

**Map of Path:** Route applied for is shown in RED DASHES starting at the junction of bridleway D46 Hungarton and bridleway D46A Hungarton continues in an easterly direction along a track to end at Billesdon Road, Hungarton. The route is shown as an ORPA on OS Maps and is not on the online Definitive Map however it is on the List of Streets but as the route is unsurfaced and described as a track it is felt a DMMO is required to establish status. The application is for a Bridleway however higher rights may exist.
