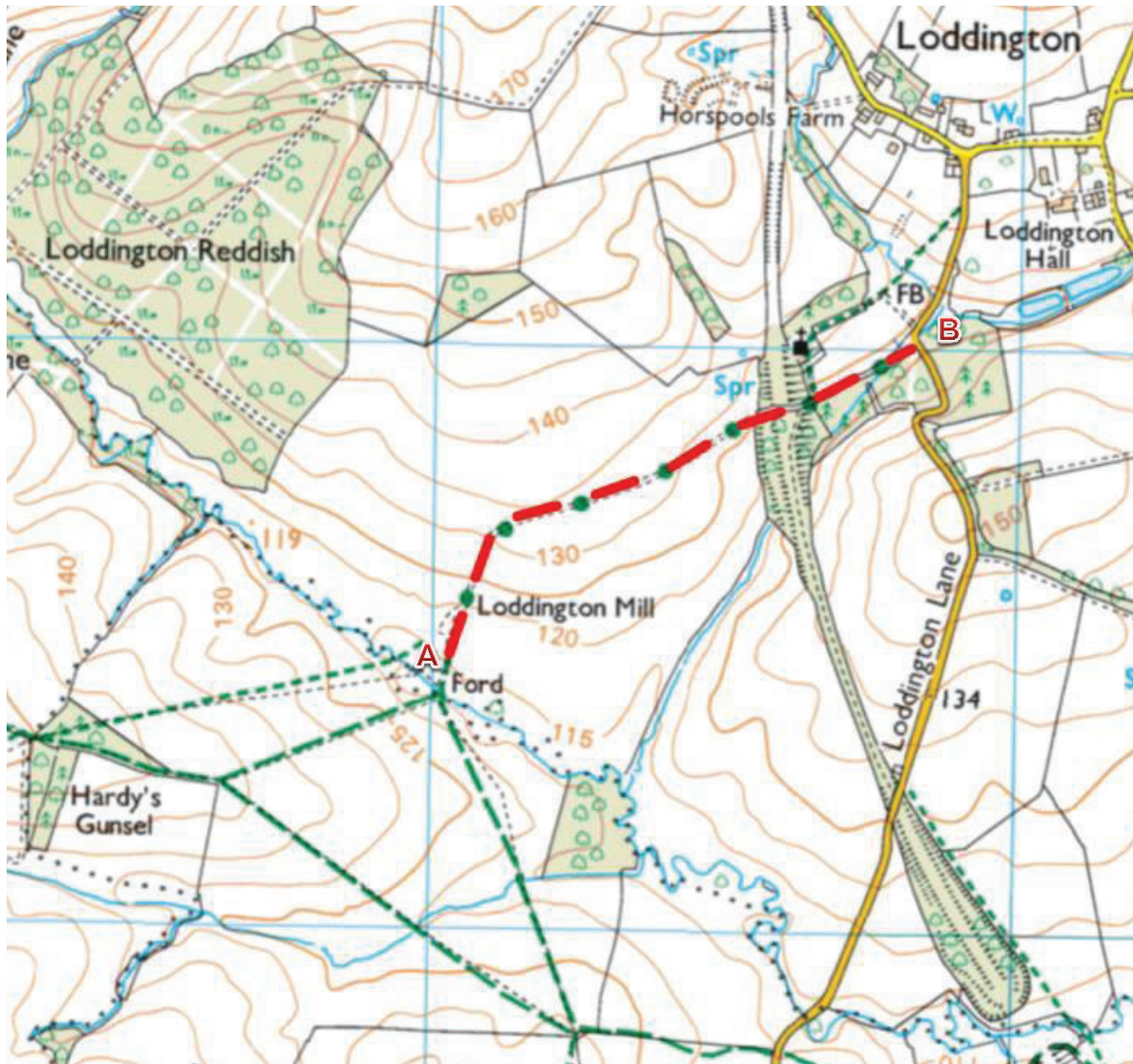

The route is shown as an ORPA on OS Maps and is not on the online Definitive Map and is described as a "track" on the List of Streets. The application is for a BOAT.
