

Map of Path: Route applied for is shown in RED DASHES starting from the end of bridleway E26 Waltham at Waltham Pastures Farm goes north west along the track to Waltham Lodge then turns north east along the track from Freeby Lane to Garthorpe Lane and ends at the junction of Garthorpe Lane, Sproxton and Waltham on the Wolds. The route is shown as an ORPA on OS Maps and is not on the online Definitive Map. The application is for a Restricted Byway, however higher rights may exist.
