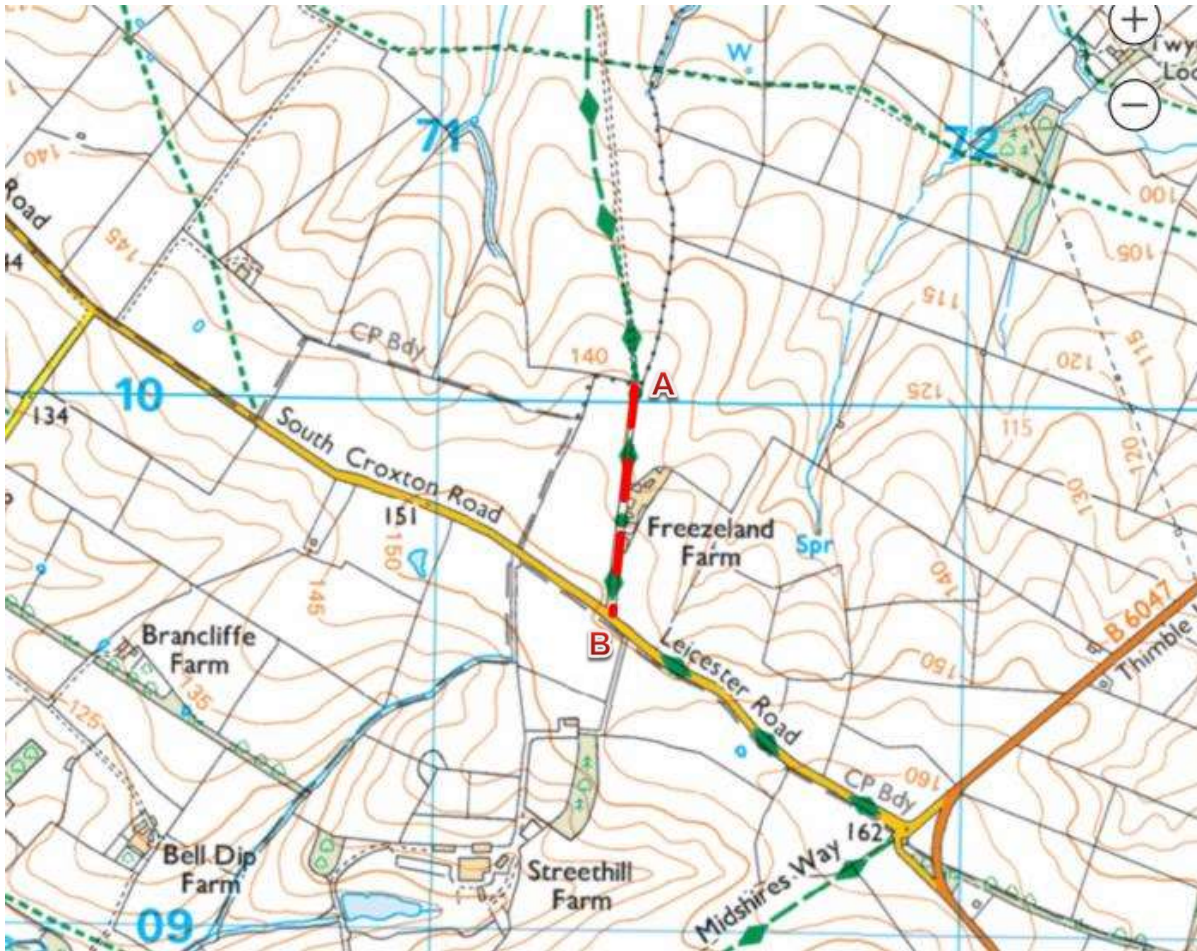

Map of Path: Route applied for is shown in RED DASHES starting at the end of bridleway I94, Gaddesby goes southwards through Freezeland Farm to end on the Leicester Road, Twyford & Thorpe Satchville. The route is shown as an ORPA on OS Maps and is not on the online Definitive Map however it is on the List of Streets but as the route is unsurfaced and described as a track it is felt a DMMO is required to establish status. The application is for a Restricted Byway however higher rights may exist.
