

Map of Path: Route applied for is shown in RED DASHES starting at Sandy Lane, Melton Mowbray goes east to end when the route becomes surfaced at Kirby Lane, Melton Mowbray. The route is shown as an ORPA on OS Maps and is not on the online Definitive Map. The route is a named lane on the list of streets however as the route is unsurfaced, the applicant felt it was important to establish status. The application is for a BOAT.
