

**Map of Path:** Route applied for is shown in RED starting from Pasture Lane, Ashby Folville, Gaddesby between Ashby Pastures & Carrington Spinney goes in a southerly direction before turning eastwards, crossing the Great Dalby Road, Ashby Folville ending at Highfield End, Ashby Folville, Gaddesby where the route becomes surfaced. The route is mostly not shown on OS Maps and is not on the online Definitive Map except for the final section that is shown as an ORPA. The application is for a Bridleway however higher rights may exist particularly for the section shown as an ORPA.
