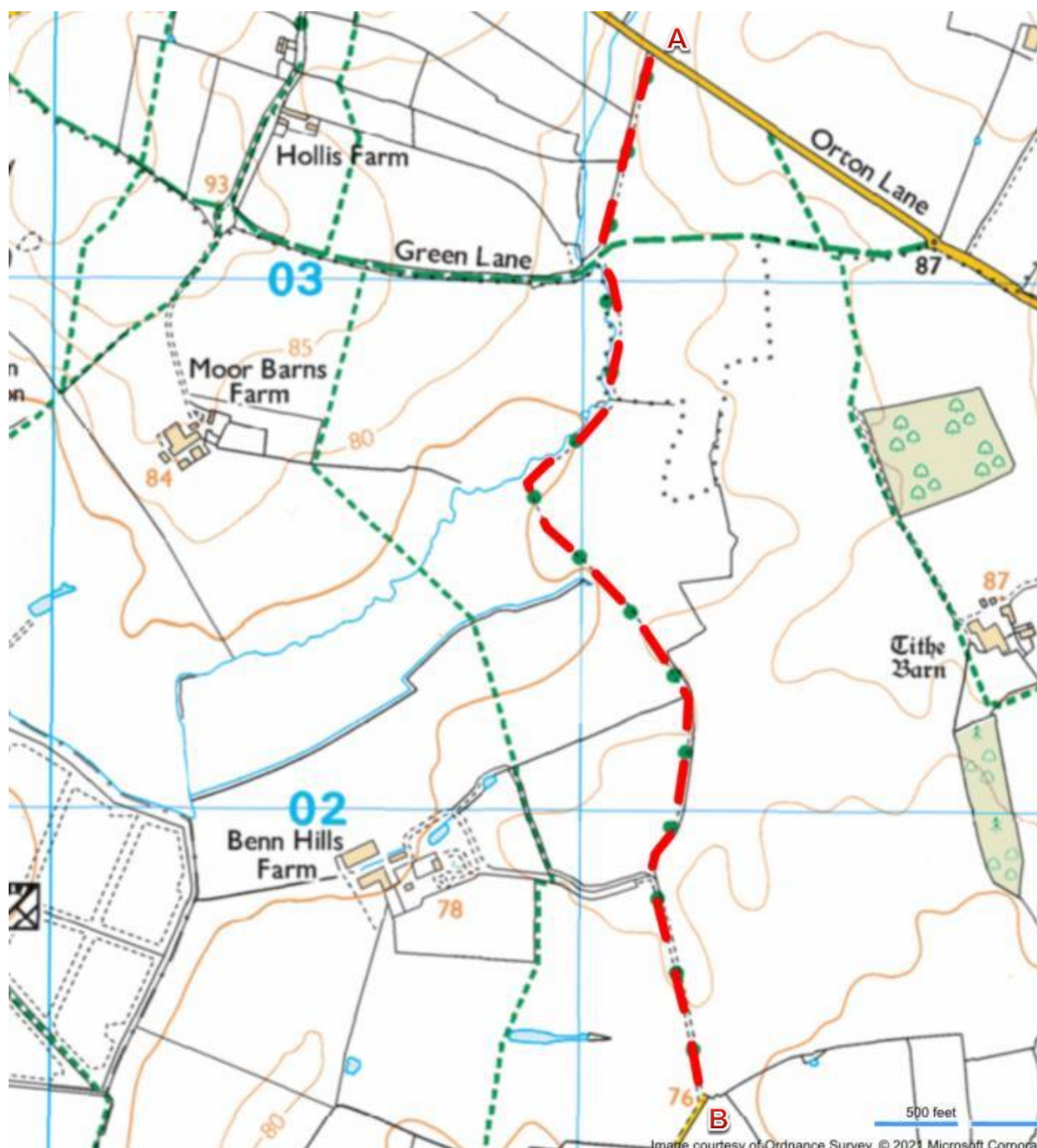

Parish: Sheepy Magna and Orton on the Hill **Grid Reference:** SK309025

Map of Path: Route applied for is shown in RED DASHES starting at Sheepy Lane, Orton on the Hill, Twycross goes southwards to end at Crow Lane, Sheepy Magna where the route becomes the responsibility of the local Council. The route is shown as an ORPA on OS Maps and is not shown on the online Definitive Map however the route is described as a “footpath from Sheepy Lane to Crow Lane, Sheepy” on the List of Streets. The application is for a bridleway however higher rights such as a Restricted Byway may exist.
