

Parish: Sheepy Magna **Grid Reference:** SK321018

Map of Path: Route applied for is shown in RED DASHES starting at Orton Lane, Sheepy Magna goes southwards to New House Grange where it briefly joins footpath T13 before following the line of the ORPA and turning east to end at Brook Side Place, Sheepy Magna. The route is shown as an ORPA and footpath on OS Maps and is partially on the online Definitive Map as a footpath however the route is partially described as a “footpath from Orton Lane to footpaths, Sheepy” on the List of Streets. The application is for a bridleway however higher rights such as Restricted byway may exist.
