## **Description of Path:**

Path starts along Pretoria Road, Ibstock where the road becomes unsurfaced at approximate grid reference SK41851053 goes eastwards to end at the start of Bridleway N101, Ibstock at approximate grid reference SK42001048. The route is shown as an ORPA on OS Maps and is not on the online Definitive Map.

The applicant for the order is the British Horse Society (BHS) whose key objective is to support and progress Project 2026 in the region.
