



RECYCLING HOUSEHOLD WASTE SITES CONDITIONS OF ACCESS AND USE

ADMISSION TO THE SITE IS CONDITIONAL UPON ACCEPTING THESE CONDITIONS

1. Do not enter this site if you are displaying symptoms of an airborne infection.
2. It is a condition that this site is provided for householders to deposit their own household waste only. Trade waste is not accepted at this site at any time; depositing or attempting to deposit trade waste is an offence.
3. For the safe use of the site, all users must always comply with the site rules, site safety notices and all instructions or directions of site staff. If in any doubt users should stop the activity and seek direction from a member of the site staff. Failure to comply with this condition, or any other condition or requirement may result in users being required to leave the site and refused further access.
4. Children (under 16's) and pets **MUST** remain in vehicles at all times, unless an emergency situation arises.
5. The County Council is not liable for any liabilities howsoever arising, resulting from:
 - access: and/or,
 - use of this site by a site user; and/or,
 - the operation of this site.

The County Council only excludes or limits its liability to the extent permitted by law. The County Council will not exclude or limit its liability for death or personal injury, or damage to property belonging to site users, caused by the negligence of the County Council, its employees and agents.

6. Whilst on site, all drivers must comply with speed limits in place, traffic flow signage, site staff instructions and comply with the Road Traffic Regulation Act. Mobile phones or other handheld devices **MUST** not be used unless the vehicle is safely parked with the ignition switched off.
7. This site is **ONLY** for the depositing of household waste and certain non-household wastes subject to the payment of applicable charges. For waste types currently accepted at the sites please visit www.leicestershire.gov.uk/waste. Where charges are applicable, the County Council reserves the right to alter the charge rates at any time without any prior notice.

8. All waste shall be deposited in the areas or containers designated for that waste or as directed by site staff. No assistance will be given by site staff, unless it is requested and needed. If you cannot safely lift your items of waste from your vehicle, please bring another adult with you to help unload.

9. Persons entering the site agree to give site staff unrestricted access to view and/or inspect the waste intended to be deposited for the purpose of ascertaining whether the waste is acceptable and assess any charge to apply. The decision of the site staff shall be final. If a site user disagrees with the site staff's assessment of whether waste is acceptable, the volume of waste and/or charges applicable, then the County Council reserves the right to require the site user to leave the site without depositing the waste.

10. All items deposited become the property of the County Council. Unauthorised removal of any item is strictly prohibited.

11. Vehicles constructed, intended or adapted for the carriage of goods and any trailer exceeding 4ft 6in (1.37m) in length, are not permitted to enter the site for the purpose of depositing waste unless the owner of the vehicle or trailer is in possession of a valid permit issued by Leicestershire County Council. 12. Certain waste streams, such as asbestos, paint and chemicals also require a permit and are restricted to being accepted on certain sites only. Please refer to the website for the most up to date information www.leicestershire.gov.uk/waste.

13. All Permits must be available for inspection on request prior to admission to the site or depositing waste. Permits on an electronic device must only be presented when a vehicle is safely parked with the ignition switched off.
