# **Best Practice Toolkit**

Partners from across the system have worked together to understand how to develop inclusive practice within education settings in Leicestershire. We worked with a group of 10 schools and parent representatives to trial and co-design a best practice toolkit. The toolkit was created because it was clear from design groups that more support was needed to navigate the SEND system successfully.

The aim of the best practice toolkit is to provide a common set of expectations for schools and families about what support should be available for children and young people with SEND, and how this support can be accessed.

It outlines the process of provision for children and young people with SEND within Leicestershire and provides a framework to talk about provision. Some of the topics include:

- Principles of the different levels of support a child could receive.
- Expectations for supporting different need types in mainstream settings.
- An introduction to EHCPs and Annual reviews.
- A full list of the external support offer in Leicestershire, including

The toolkit will be available later this term to be used by everyone across the system, including SENCOs and local authority teams, to help ensure that we are all offering the right support at the right time for children across Leicestershire to meet their outcomes. We will also be developing training and resources to support consistency across the system.

# Wider TSIL updates

The Early Years Transition Document is available now on the Leicestershire County Council website to be used by early years SENCos and other professionals.

Special School Outreach – we are developing a new model with each of the heads of special schools who offer outreach. From September 2023 we are hoping to trial new types of outreach support for our mainstream settings. We will then be looking to understand how impactful the new offer is to ensure it is adapted and best supports the system to meet the needs of Leicestershire children going forwards.

The Synergy Schools (Gateway) Portal Trials – we are continuing to explore how useful access to the portal is for SENCos to share information with parents. The evaluation of the trials will conclude this term and we are continuing to look at how we can roll this out to schools and academies later this year.

#### **Utilising Our Specialist**

**Provisions –** we are in the process of documenting what all our resource bases offer to provide to our schools and parent/carers, alongside working on building a new tool to improve tracking of our placement allocations.

Educational Psychologist Support - Leicestershire County Council is being supported by a team of locum Educational Psychologists (EPs) to support us to reduce the current backlog of EHCNAs. To ensure the backlog doesn't return to the levels we are seeing currently, LCC is exploring a number of different options, including:

- Developing the EP workforce
- Reviewing approaches to assessment

# Changes within the SENA Service

These changes will lead to more effective prioritisation and allocation of work, and remodelling teams and roles.



# **First family hub** for Leicestershire opens

#### Leicestershire's first ever 'Family Hub' has officially opened.

The new 'one-stop-shop' where parents and carers can access support and advice is now up and running in Coalville.

It's the first in a raft of family hubs for the county where families with children between 0 -19 (or 25 for young people with special educational needs or disabilities) can receive information on a range of issues.

Staff can give support and advice on a variety of topics including health, relationships, education, employment, finance and housing, as well as signposting to help from other local agencies and organisations.

The Coalville centre is one of more than 20 family hub locations that have been confirmed so far by Leicestershire County Council, with more areas being considered. Loughborough's Family Hub opened on June 1, followed by Melton and Hinckley later in the month and Market Harborough and Wigston Magna in August.

Leicestershire is one of 12 local authorities to secure a slice of a £12m pot of grant funding to transform the way services are delivered for families.

As well as creating the physical hubs, there are plans in the county to carry out outreach work and create a new website containing helpful family information and advice.

This will mean that the hubs, whether in a building or accessed digitally, will be where information, advice and support will be found easily in one place.

# Fairestershire

The idea is that parents and carers can easily receive support right from conception, helping them to navigate parenting through the early years, right into adulthood.

The full network of physical hubs, which will make use of existing spaces such as Children and Family Wellbeing Centres and libraries, is expected to be fully open by spring 2024.

# Leicestershire local area **Accelerated Progress Plan (APP)**

The Leicestershire local area received a SEND re-inspection in November 2022. Two areas were the focus of the inspection:

- 1. Lack of a Joint Commissioning Strategy
- 2. The quality of Education, Health and Care Plans (EHCP's)

The inspection team reported that the lack of a Joint Commissioning Strategy had made satisfactory progress but that the quality of EHCP's needed further work.

The Department for Education (DfE) has requested that the local area develop an Accelerated Progress Plan (APP) of EHCP's. The purpose of the APP is to ensure accelerated progress on a set of actions. The Local Authority, Integrated Commissioning Board (ICB - formerly the Clinical Commissioning Group) and SEND Hub (Leicestershire's Parent Carer Forum) developed the plan over the required four-week period and was signed-off by the DfE. The DfE will meet formally with the local area in September to assess progress being made.

## Three workstreams have been identified to be worked on:

- 1. Quality of EHC Plans following initial EHC Needs Assessment: Consistent implementation of a robust, child-centred, statutorily compliant EHC needs assessment, with education, health and care joint working. This will deliver accurate identification of needs and provision for children and young people with SEND.
- 2. Quality of EHC Plans following amendment at Annual Review: An equitable and consistent process which ensures all EHC plans remain a relevant and accurate reflection of a child's or young person's needs, outcomes to be achieved and required provision.
- 3. A rigorous multi-agency quality assurance process, which provides meaningful measures of performance, collecting both quantitative and qualitative data from across the tripartite system, to create a continuous review and improvement cycle with effective feedback into both strategy and operation.

A range of key performance indicators (KPI's), along with survey information will provide information on the progress being made. The KPI's include the issue of initial EHCP's within 20 weeks alongside a number of KPI's that form the Annual Review process. The Transforming SEND and Inclusion in Leicestershire (TSIL) programme continues to bring together a range of information that will inform processes that are carried out within the EHC needs assessment process and the Annual Review process. There will be the opportunity to take another look at the EHCP template.

An open invitation to staff across the partnership and the SEND Hub was offered to participate in training provided by the National Development Team for Inclusion (NDTi) with a particular focus on Preparation for Adulthood and a session on Supported Internships. Further training will be led by the Council for Disabled Children (CDC) on audits and the quality assurance process. This will support the current quality assurance process that takes place bi-monthly to further develop exemplars to provide guidance for advice givers to improve the quality of EHCP's.

The Local Authority has invested in additional capacity to begin to bring down the length of time taken for initial EHCP's to be issued. There is additional locum Educational Psychologist support to carry out statutory assessment and additional staffing to work on the backlog of Annual Reviews amendments that are in the system..



# Leicestershire Special Schools given **Good Ofsted rating**

Both Foxfield Academy and Oakfield School have recently received a 'Good' rating in their latest Ofsted inspections.

Foxfields Academy is a specialist all through school for SEMH pupils (Social, Emotional, Mental Health) aged 5 to 16 years, and Oakfield is for primary aged children (from the term after their fifth birthday) who have been permanently excluded from school or are at risk of permanent exclusion.

Oakfield was previously inspected in 2017 and has maintained a 'Good' rating. In the latest report it was observed that "The school is well led and managed. Senior leaders understand the school's strengths and areas needing development". The report also noted "Staff manage pupils" behaviour very well. They have high expectations of pupils and use appropriate strategies to engage pupils with their learning."

#### Justine Roberts, Headteacher of Oakfield Short Stay Primary, has said:

"This is a fantastic achievement for everyone involved with the school. The good outcome reflects the hard work and commitment from all and we are delighted that the achievements of our pupils have been recognised."

#### In Foxfield's first inspection report since opening in 2021, the school received an

#### outstanding for personal development. The report noted

"pupils of all ages thrive at Foxfields Academy". Ofsted also included that "the school caters very well for pupils' academic and social and emotional needs. Pupils who may have had negative experiences in the past receive well-planned support to overcome their difficulties".

#### Ashley Caress, Headteacher of Foxfields Academy, is delighted with the outcome:

"I am extremely proud of everyone associated with our school. I feel that the report reflects the efforts of our school community and provides us with as excellent platform to continue to grow and develop in the future".
