Land to the south of Market Harborough

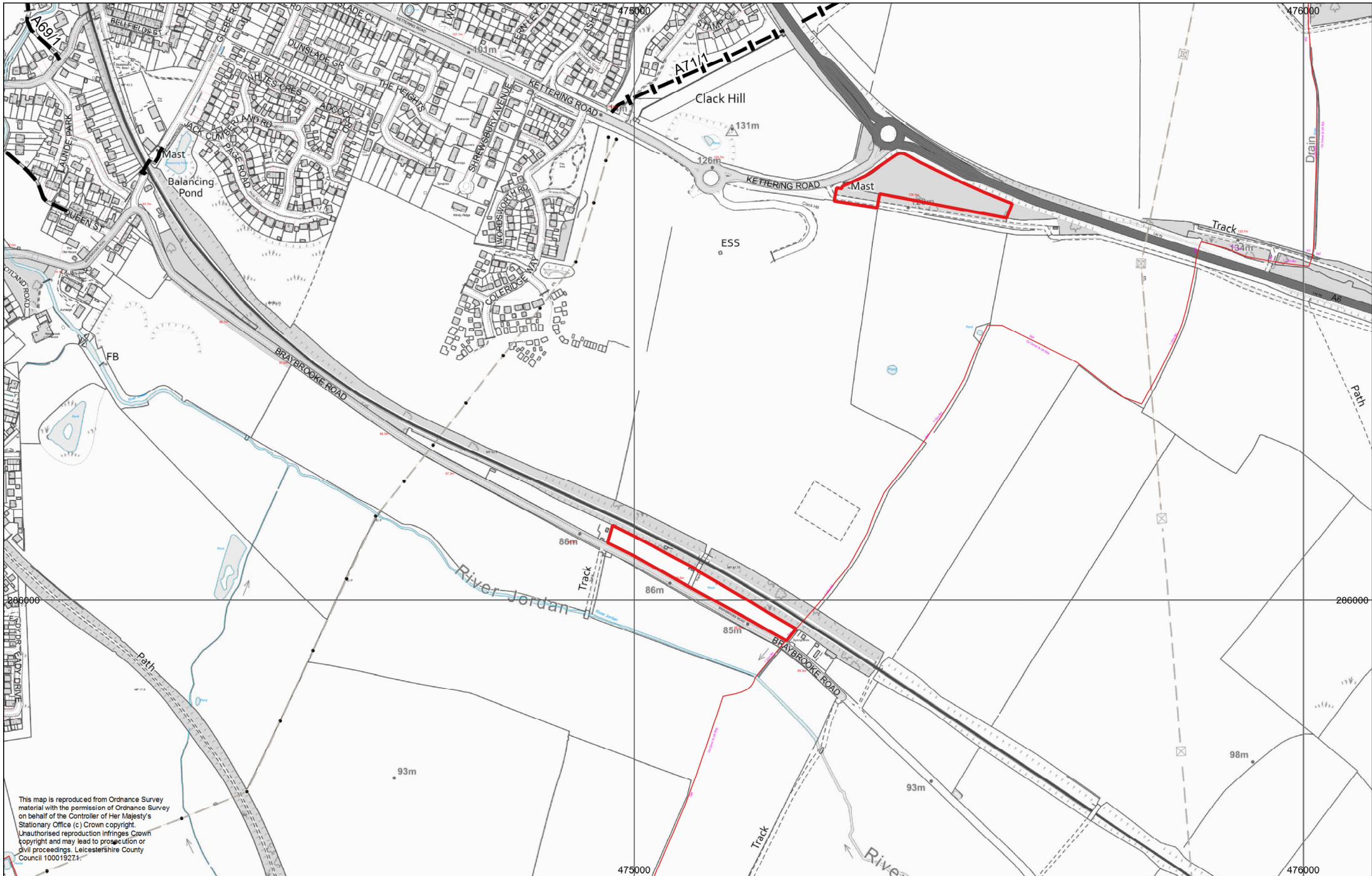
