ROAD TRAFFIC REGULATION ACT 1984 - SECTION 14 (2)

TEMPORARY IMPLEMENTATION OF 7.5TONNE WEIGHT RESTRICTION EXCEPT FOR ACCESS TEMPORARY PROHIBITION OF THROUGH TRAFFIC

SAXBY ROAD, MELTON MOWBRAY; MAIN ROAD, WOODFOLD LANE, UNNAMED ROAD FROM B676 TO MAIN ROAD, WALTHAM LANE, STAPLEFORD ROAD, WYFORDBY LANE, SAWGATE LANE, CUCKOO HILL, HOLYGATE ROAD, FREEBY; GLEBE ROAD, WYMONDHAM;

IN VARIOUS PARISHES IN THE DISTRICT OF MELTON MOWBRAY, FRISBY, FREEBY, BURTON LAZARS, WHISSENDINE AND WYMONDAHM (2024)

Leicestershire County Council in exercise of its powers under Section 14 (2) of the Road Traffic Regulation Act 1984 hereby gives Notice that the road detailed in the schedule below will subject to a Temporary Traffic Regulation Order which includes a temporary 7.5tonne weight restriction except for access.

The road shown in the schedule below may legally be restricted to a temporary 7.5tonne weight restriction except for access for a period of up to 21 days from from Saturday 23rd March 2024, but the order is expected to be in force for 21 days for public safety whilst **Galliford Try undertakes works relating to the Melton Mowbray Distributor Road on behalf of Leicestershire County Council.** The Order will come into force when the appropriate traffic signs are erected.

SCHEDULE ONE TEMPORARY IMPLEMENTATION OF 7.5TONNE WEIGHT RESTRICTION EXCEPT FOR ACCESS

B676 SAXBY ROAD, MELTON MOWBRAY – from the junction with Norman Way to Saxby Road, Freeby

B676 SAXBY ROAD, FREEBY – from Saxby Road, Melton Mowbray to the junction with Woodfold Road, Freeby

MAIN ROAD, FREEBY – from the junction with the B676 to Wyfordby Lane, NE UNNAMED ROAD FROM B676 TO MAIN ROAD – at its junction with the B676 STAPLEFORD ROAD, FREEBY – from the junction with the B676 to Whissendine WYFORDBY LANE, FREEBY – from the junction with Stapleford Road, Freeby to Main Road, Freeby

SAWGATE LANE, FREEBY – from the junction with Stapleford Road, Freeby to the junction with Cross Lane

CROSS LANE, BURTON AND DALBY – from Sawgate Lane, Freeby to Melton Road, Burton and Dalby

HOLLOW LANE, BURTON AND DALBY – from Sawgate Lane, Freeby to New Road, Burton and Dalby

NEW ROAD, BURTON AND DALBY – from New Road,to Melton Road STAPLEFORD ROAD, FREEBY – from Whissendine Road to Cuckoo Hill CUCKOO HILL, FREEBY – from Stapleford Road, Freeby (off Whissendine Road) to Stapleford Road, Freeby (north of Cuckoo Hill)

HOLYGATE ROAD, FREEBY – from Stapleford Road, Freeby to Glebe Road, Wymondham

GLEBE ROAD, WYMONDHAM – from Holygate Road, Freeby to Melton Road, Wymondham
