THE LEICESTERSHIRE COUNTY COUNCIL hereby gives notice that it proposes to make an Order under Sections 5, 84 and part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act"), and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, the effect of which will be:

1. To impose a 20-mph speed limit on part of Main Street, Townend, Barley Leas and Church Lane, Hungarton

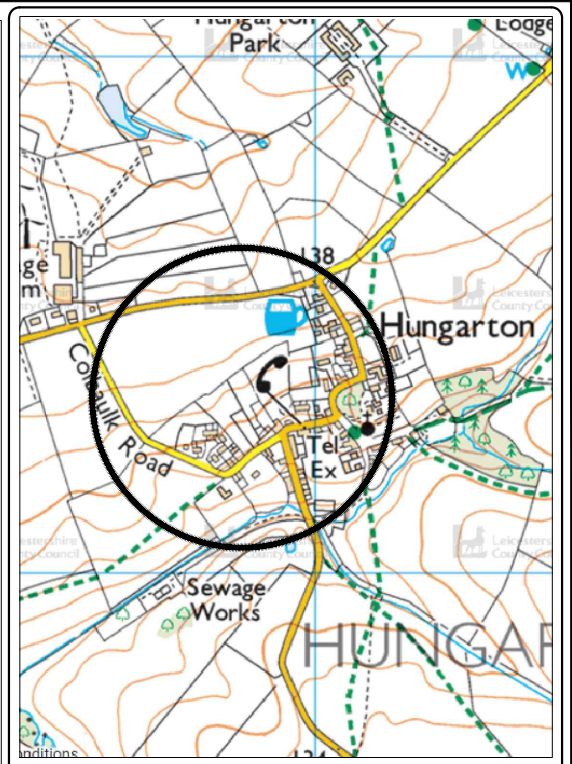
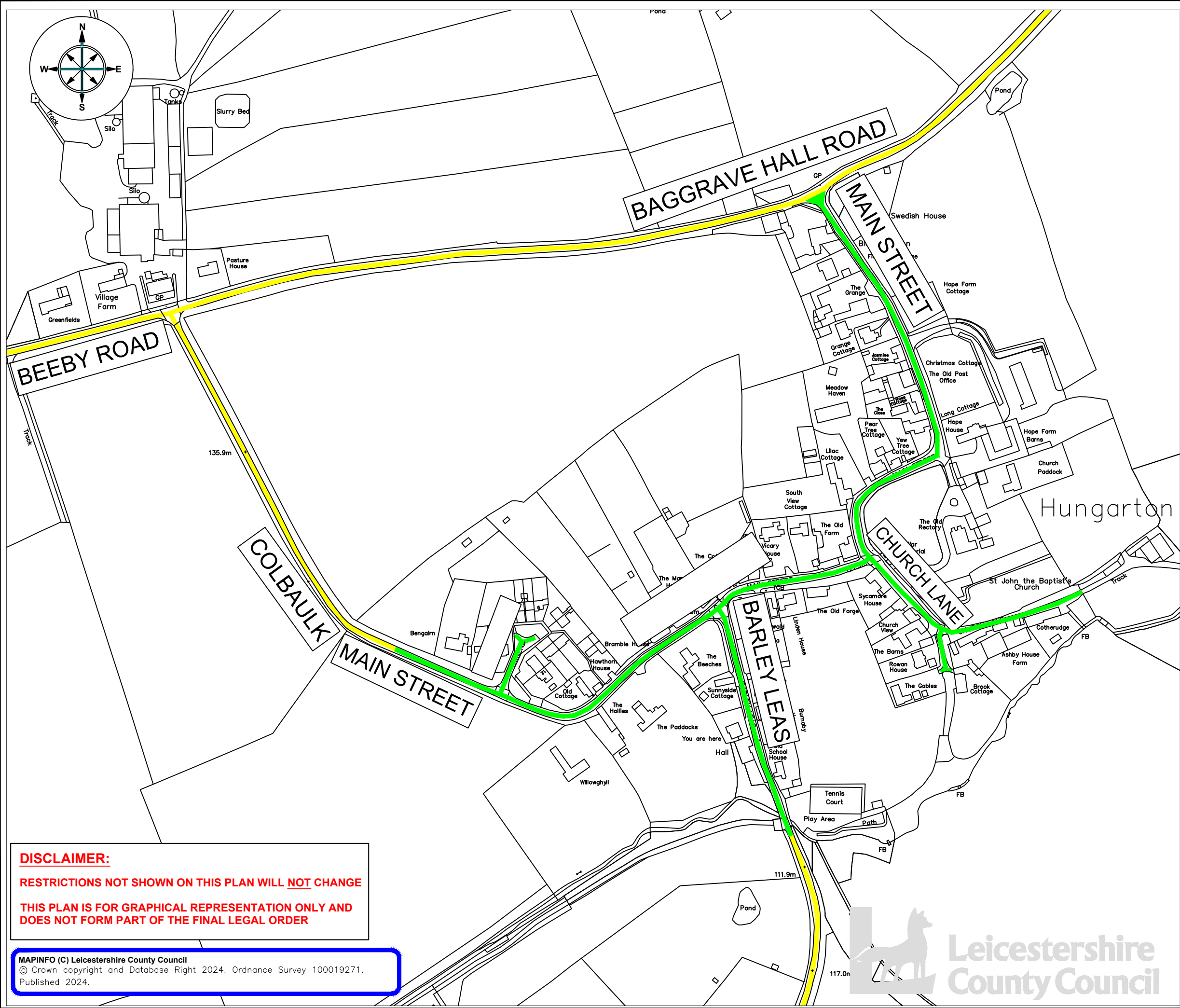

PROPOSED 20MPH SPEED LIMIT

STATEMENT OF REASONS

Leicestershire County Council (LCC) is proposing to lower the speed limit from 30mph to **20mph** on the following roads Main Street, Townend, Barley Leas and Church Lane in the village of Hungarton.

The 20mph speed limit is being introduced after speed surveys showed the mean speed to be conducive with a 20mph speed limit.

The order is being introduced to improve road safety.

The Leicestershire County Council ("the Council") in exercise of its powers under Sections 5 , 84 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the chief officer of police in accordance with Part III of Schedule 9 to the Act and Regulation 23 of the Local Authorities Traffic Order (Procedure) England and Wales Regulations 1996, hereby makes the following Order:-

1. This Order may be cited as "The Leicestershire County Council (Various Road, Hungarton, District of Harborough) (Imposition of 20mph Speed Limit) Order 202 "
2. The Order shall come into force on the day of 202
3. The Order specified in Schedule 1 to this Order is hereby revoked in full
4. No person shall drive any motor vehicle at a speed exceeding 20 MPH on the lengths of roads as specified in Schedule 2 to this Order.
5. The plan annexed to this Order and marked drawing number TM5137/T1/1 is for identification purposes only.

From its junction with Main Street, Hungarton to a point 176 metres south of its junction with Main
Street, Hungarton

Church Lane

For its entire length
