NOTICE is hereby given that Public Local Inquiries in connection with the Orders mentioned below will be held by an Inspector appointed for this purpose by the Secretary of State for Transport **beginning at 10.00am on Tuesday 11 June 2024 at The Fieldhead, Markfield Lane, Markfield, Leicestershire LE67 9PS** to hear representations from remaining objectors (as defined in the Compulsory Purchase (Inquiries Procedure) Rules 2007) and statutory objectors (as defined in the Highways (Inquiries Procedure) Rules 1994), from any other persons having an interest in the land the subject of the Compulsory Purchase Order and, at the Inspector's discretion, to hear representations from any other persons who may desire to appear and be heard.

THE ORDERS have been made by Leicestershire County Council under the above-mentioned Acts and submitted to the Secretary of State for Transport for confirmation and are:

**(1) THE LEICESTERSHIRE COUNTY COUNCIL (A511 GROWTH CORRIDOR) (SIDE ROADS) ORDER 2023.** This is an Order under Sections 14 and 125 of the Highways Act 1980.

**(2) THE LEICESTERSHIRE COUNTY COUNCIL (A511 GROWTH CORRIDOR) COMPULSORY PURCHASE ORDER 2023.** This is an Order under Sections 239, 240, 246, 250 and 260 of the Highways Act 1980.

THE ORDERS relate to proposals to carry out improvements along the A511 between Hoo Ash Roundabout in the west and Field Head Roundabout in the east and to construct a new link road between the Bardon Road roundabout on the A511 Bardon Road to connect to the spine road being delivered as part of the Grange Road residential development.
