Location

Market Harborough is an affluent and attractive market town in South Leicestershire, lying some 15 miles south east of Leicester and 18 miles north of Northampton. According to the census in 2021, the district population was approximately 24,171 people.

The town is situated alongside the A6, A427 and A508 trunk roads. The M1 motorway lies some 12 miles west of the town, the A14 east / west link road is some 6 miles to the south. In terms of rail connectivity, Market Harborough has a mainline station which provides access to London St Pancras in under one hour's travelling time

The property is situated in a predominantly residential area within the town and occupies a position to the east side of Roman Way, set back from the road by way of a private driveway. The property is within a 5-minute walk of the main Town Centre and approximately 1/2 a mile from Market Harborough Midlands Mainline Station. The Symington's Recreation Ground is located directly to the rear of the site.

Description

The subject property comprises a detached, single-storey purposebuilt day centre of brick construction, beneath a series of pitched concrete tiled roofs, arranged in a square format surrounding an outdoor quadrangle. The windows in the building are all double glazed.

Internally, the accommodation has been arranged to provide an array of small and large offices / meeting rooms, a large open plan dining area, together with a kitchen with associated preparation area. Ladies, gents and disabled WCs are provided throughout. There are also a number of storage and workshop areas, one of which benefits from a loading bay fitted with a roller shutter door.

Externally, there are approximately 30 car parking spaces around the exterior of the complex which include several disabled and minibus bays. Part of the site also includes a pond.

The total site area extends to approximately 1.86 acres. A plan showing the full extent of the site is located on the rear page of this brochure and is edged in red.


