Scam Alert – "Hi Dad, Hi Mum" fake texts

The 'Hi Mum' or 'Hi Dad' scam is doing the rounds again. The text purports to be from your child asking you to save a new number - it's likely that fraudulent requests for money will follow. This scam preys on our natural concern for the wellbeing of a child.

Remember:

X Do not transfer funds without further checks.


• Enquire further by asking who specifically it is by name and by calling them or asking for a voice note.

- Contact your child on the last known contact number you have for them.
- If you receive a suspicious text message, you can report it by

forwarding it to 7726 before blocking the number.


• Speak to your bank if you are worried you have given money to a fraudster.

Then and now...



The checks test if the amount of fuel a pump shows the motorist is being dispensed is actually delivered into the vehicle. To prevent fraud, fuel pumps are 'sealed' to prevent adjustment or tampering and to tamper with them is against the law.

If you think you may have been short-changed you can report it on our Leicestershire Trading Standards <u>website</u>.

This is a throwback to Trading Standards petrol pump testing in 1963, a lot has changed since then and technology has moved on, however the work we do remains the same.

Fuel pumps are tested to ensure that they are legally compliant. This way we ensure that petrol pumps are dispensing accurately, and you get the correct amount of fuel for your money.



Show us your smile!

Are you using safe teeth whitening products? Leicestershire Trading Standards Service recently stopped and tested a consignment of teeth whitening products at East Midlands Airport that contained 9 times the legal limit for Hydrogen Peroxide. The ingredients did not list Hydrogen Peroxide which is a restricted ingredient in the UK.

Beware of funeral scams!

Criminals are preying on bereaved families with bogus donation forms and fake online funeral streaming services, warns the <u>Chartered Institute of Trading Standards</u>.



The scam begins with criminals seeking out funeral notices and then setting up fake Facebook accounts which offer opportunities to donate money in memory of the recently deceased, or to watch a live stream of their funeral. In either case, the postings are entirely fraudulent and a ploy to extract money from mourning friends and relatives.

A grieving family from Lincolnshire discovered a <u>fake Facebook page</u> following the funeral of their son. The bogus site used a picture of him and claimed to have footage of the service, even though it was not filmed. The site was set up to gather people's data and solicit cash donations which would go to the scammer not charity.

Remember:

- A funeral is a public event that you should never be charged to attend in person or online.
- Do not to trust links for donations found online check with the official funeral director for information about donations.
- As with other scams never give away personal details.
- Contact your bank immediately if you are concerned that you have paid money to a scammer.

Don't forget: If you are considering buying a personal funeral plan make sure the provider is regulated by the <u>Financial Conduct Authority</u>.

Labels matter

Have you ever bought a food with the expectation that it contains lots of a desired ingredient, only to eat it and find it contains very little of that ingredient, making you feel short changed?

The percentage of certain characterising ingredients in a food must be declared within the ingredients list. This includes ingredients highlighted in the name of the food, or those which are synonymous with that food for example a "chocolate chip cookie".

The rule prevents a cheaper product from



being marketed as a quality product because the percentage of the characterising ingredients are clearly labelled in the ingredients list, you just need to know where to look for it!

Watch out for heavy metals



In the UK, the presence of Cadmium, Lead and Nickel are heavily restricted in products like metal jewellery.

Recent checks at East Midlands Airport led to the removal of metal watches found to contain a high percentage of nickel which is an allergen. The importer had not made any checks to ensure the goods were safe before bringing them into the country.

Scam Alert - Microsoft PC support scam calls



We have had reports from concerned Leicestershire residents who received phone calls from individuals pretending to be from Microsoft, offering to fix a problem with their computer, stating otherwise the PC would shut down.

Even when one resident put the phone down the

caller rang again multiple times, using different numbers and becoming increasingly aggressive.

Microsoft do not ring offering help in this way. Do not continue the conversation with someone claiming to be ringing from the company. They are trying to steal your personal or financial information and if you allow them to remote into your computer to perform a "fix," they will often install malware, ransomware, or other unwanted programs that can steal your information or damage your data or device.

No blame, no shame – scam campaign

This kind of language can make a victim feel:

- Ashamed
- Embarrassed
- Fearful of reactions
- Afraid of reporting

Aquatic toys are just toys!

Enjoying the summer sunshine by the paddling pool or swimming pool?

Remember - items such as inflatable toys, novelty floating foam toys, and kick boards and arm bands to help when learning to swim are not designed to prevent drowning. They can give a false sense of safety, leading to children getting into difficulty.

When buying, check for CE or UK CA marking and follow

instructions for safe use, including recommended ages.

- Very young children should be kept under constant close supervision.
- Inflatables should be deflated, and all toys taken out of the water when not in use so young children aren't tempted to play unsupervised in water.
- Before each use, check for damage or leaks.
- Clean after use to prevent slime, mould and bacteria build-up.
