



STATEMENT OF REASONS

Leicestershire County Council proposes to make the following order.

To facilitate the new staggered signalised toucan crossing facility on Lutterworth Southern Bypass (A4303), Lutterworth, it is proposed to reduce part of the existing national speed limit and introduce a 40mph speed limit on Lutterworth Southern Bypass (A4303) and Coventry Road (A4303), Lutterworth.

This is part of the planning conditions for the new Leaders Farm development.

This scheme is being introduced on the grounds of road safety.

These proposals are being funded by Leicestershire County Council and are linked to the Leaders Farm development site.

Separate to the above proposals the existing 40mph speed limit on A4303 Lutterworth Road (A4303), Lutterworth has been included within this order to correct an anomaly identified. There will be no changes to the extents.

The proposals are shown in plan TMI.003./T1/1/B-1&2.
