50MPH SPEED LIMIT) ORDER 2025

The Leicestershire County Council ("the Council") in exercise of its powers under Sections 5, 84 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers, after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby makes the following Order:-

1. This Order may be cited as "The Leicestershire County Council, (Stanton Lane, in the Parishes of Ibstock and Stanton under Bardon, in the District of North-West Leicestershire and the Borough of Hinckley and Bosworth) (Imposition of 50mph Speed Limit) Order 2025"
2. The Order shall come into force on the first day of September 2025
3. The Order specified in Schedule 1 is hereby revoked in part.
4. No person shall drive any motor vehicle at a speed exceeding 50 MPH on the length of road specified in Schedule 2 to this Order
5. The plan annexed to this Order and marked drawing number TMD.048/T1/1/1 is for identification purposes only

From its roundabout junction with B585 West Lane to a point 118 metres south-east of its roundabout junction with B585 West Lane

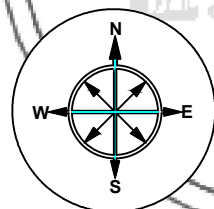

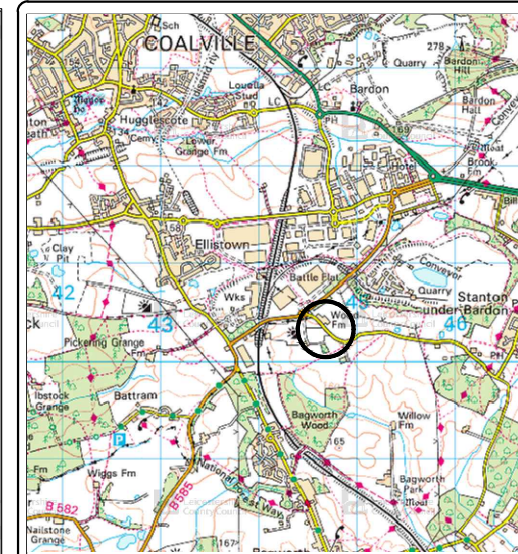
