NOTICE TO UNDERTAKERS - SECTION 58

## THIS IS A NOTICE, NOT A SEARCH

The LEICESTERSHIRE COUNTY COUNCIL by its Director of Environment and Transport, acting in virtue of the powers vested in the Council as Highway Authority, hereby gives 3 months advance notice under Section 58 of the Act of its intention to execute substantial road works in accordance with the accompanying plan.

Subject to the exemptions in the Act and Regulations under it, no street works may be executed for a period of 36 months from the completion of the works described without the consent of the said Leicestershire County Council. Should such street works be planned you are requested to contact the above-named officer to discuss how the works can best be co-ordinated.


