

#### STATEMENT OF REASONS

Leicestershire County Council proposes to make the following order on behalf of developers to introduce No Waiting at Any Time restrictions on Lountside at its junction with the A511 from roundabout at the junction of the A42, A511 and A512 Ashby Road to Nottingham Road, Ashby de la Zouch.

The proposed restrictions seek to mitigate the impact of potentially obstructive onstreet parking on Lountside at and on its roundabout junction with the A511.

It is also necessary to extend the existing waiting restrictions on both parts of Coalfield Way in its entirety, to prevent obstructive parking from HGVs. Introducing further double yellow lines will prevent HGVs parking on the footway / and alleviate congestion which prevents the safe movement of traffic flows during peak times.

The proposed restrictions seek to benefit the safety for all road users in this location.

This scheme is being introduced on the grounds of road safety.






