

Leicestershire County Council proposes to make the following order on behalf The Lady Byron School to introduce No Loading / Waiting at Any Time restrictions on Springfield Street (A508), Northampton Road (A508) and Welland Park Road in Market Harborough.

The new school in Market Harborough is scheduled to open from August 2025.
