To impose No Loading or Waiting at Any Time Restrictions on parts of Northampton Road, Springfield Street and Welland Park Road, Market Harborough




**STATEMENT OF REASONS**

Leicestershire County Council proposes to make the following order on behalf The Lady Byron School to introduce No Loading / Waiting at Any Time restrictions on Springfield Street (A508), Northampton Road (A508) and Welland Park Road in Market Harborough.

The new school in Market Harborough is scheduled to open from August 2025. The proposed no loading restrictions aim to prevent drivers from stopping to drop off or pick up students on these specific roads and at their junctions in the vicinity of the school. The proposed restrictions help create a safer environment for all road users, including pedestrians and cyclists.

This scheme is being introduced on the grounds of road safety.




