

STATEMENT OF REASONS

Leicestershire County Council proposes to make the following orders:

To introduce mandatory School Keep-Clear markings outside the entrances to South Charnwood High School, Broad Lane, Markfield. The restrictions are being advertised due to concerns raised with the school and County Council; regarding vehicles parking closely to the school entrance, restricting visibility and creating a dangerous environment for children entering and exiting the school.

Existing markings are present at the school entrance, and the proposal shall restrict vehicles from parking where new markings are proposed across the road. Restrictions are being proposed, between Monday to Friday 8am – 4pm.

In addition to the mandatory keep clear markings, no waiting at any time restrictions are also being proposed to limit the amount of parking within close proximity of the school gates to create a safe highway environment allowing for safe passage for all its users.




