- 5. No person shall drive any motor vehicle at a speed exceeding 40 MPH on the lengths of roads specified in Schedule 2 to this Order

- 6. No person shall drive any motor vehicle at a speed exceeding 50 MPH on the lengths of roads specified in Schedule 3 to this Order
