1. To make changes to the mandatory disabled parking bays on Market Place, Market Bosworth

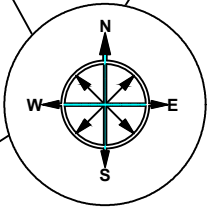

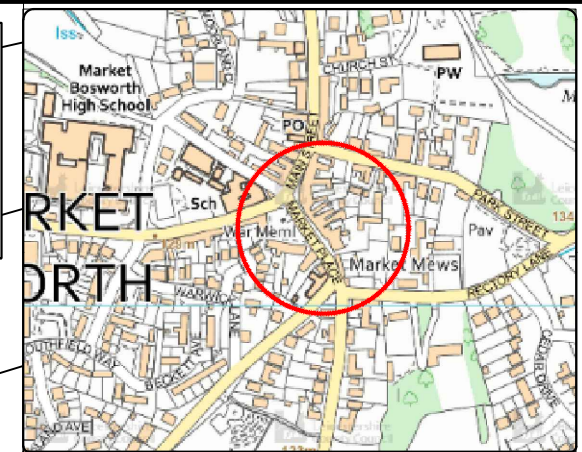

STATEMENT OF REASONS

Leicestershire County Council is proposing to make changes to the mandatory disabled parking bays on Market Place, Market Bosworth.

The new timings are proposed to ensure the mandatory disabled bays run parallel with the existing limited waiting bay timings.

This will ensure the disabled bays are available for short-stay opportunities with visitors to the area during the working day.
