
To impose a 50mph speed limit on part of Nanpantan Road, Nanpantan, Loughborough

Statement of reasons

Leicestershire County Council proposes to reduce the speed limit from national speed limit to 50mph on a section of Nanpantan Road south of Nanpantan crossroads.

The speed limit on Nanpantan Road is 50mph at the Ingleberry Road/ Shepshed Road crossroads, north of this junction it becomes national speed limit and then goes down to 40mph at Nanpantan.

The speed limit on Nanpantan Road that is currently national speed limit is proposed to be reduced to 50mph to give consistency to the speed limits on the roads in that area. The proposals are shown on plan TM5187/T1/1/ CONSULT

As part of this order the existing 40mph speed limit at Nanpantan is being included but is unchanged to bring our orders up to date.

The order is being carried out on the grounds of improving road safety.




