THE LEICESTERSHIRE COUNTY COUNCIL hereby gives notice that it proposes to make an Order under Sections 1, 2, 4, 5, 19, 32, 35, 45, 46, 47, 49 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act"), and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, the effect of which will be:

To impose No Waiting at Any Time restrictions on parts of East End, Waltham Lane and Unnamed Road, Long Clawson.

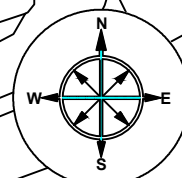

STATEMENT OF REASONS

Leicestershire County Council proposes to make the following order.

On behalf of the developer Jelson Homes, it is necessary to implement No Waiting at Any Time restrictions.

The proposed waiting restrictions will mitigate the impact of potentially obstructive on-street parking near to the proposed development and ensure a safe highway environment allowing for safe passage for all of its users.

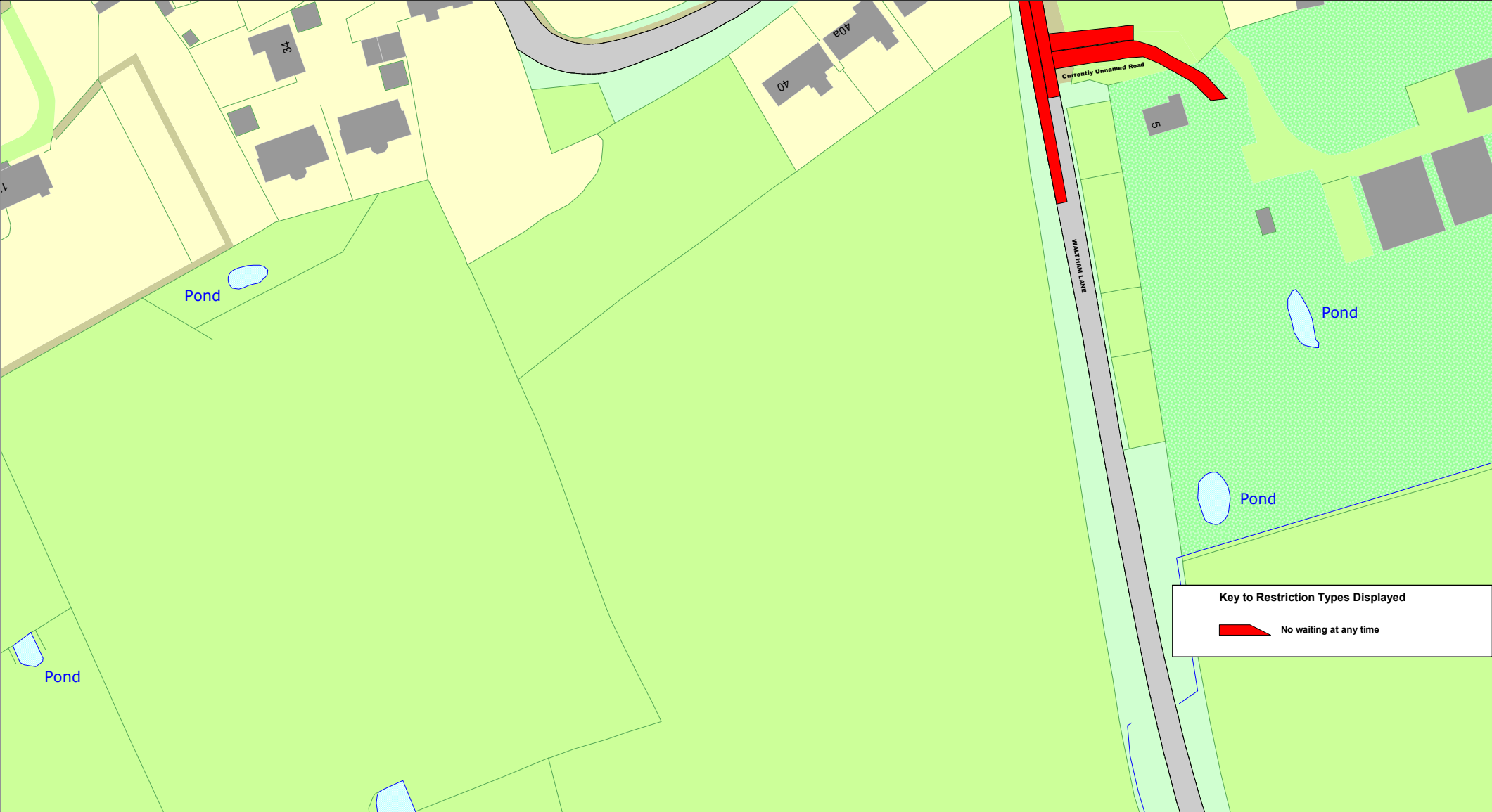
