THE LEICESTERSHIRE COUNTY COUNCIL hereby gives notice that it proposes to make an Order under Sections 1, 2, 4, 5, 19, 32, 35, 45, 46, 47, 49 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act"), and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, the effect of which will be:

To extend no waiting at any time restrictions along part of Clarence Street to facilitate the introduction of a one-way system

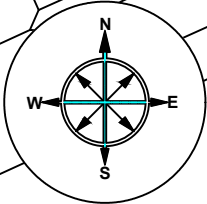

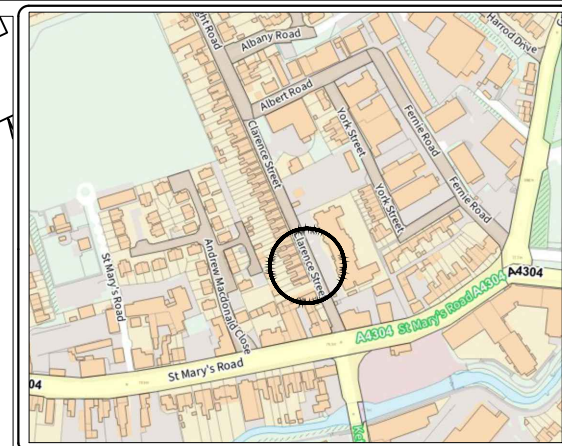

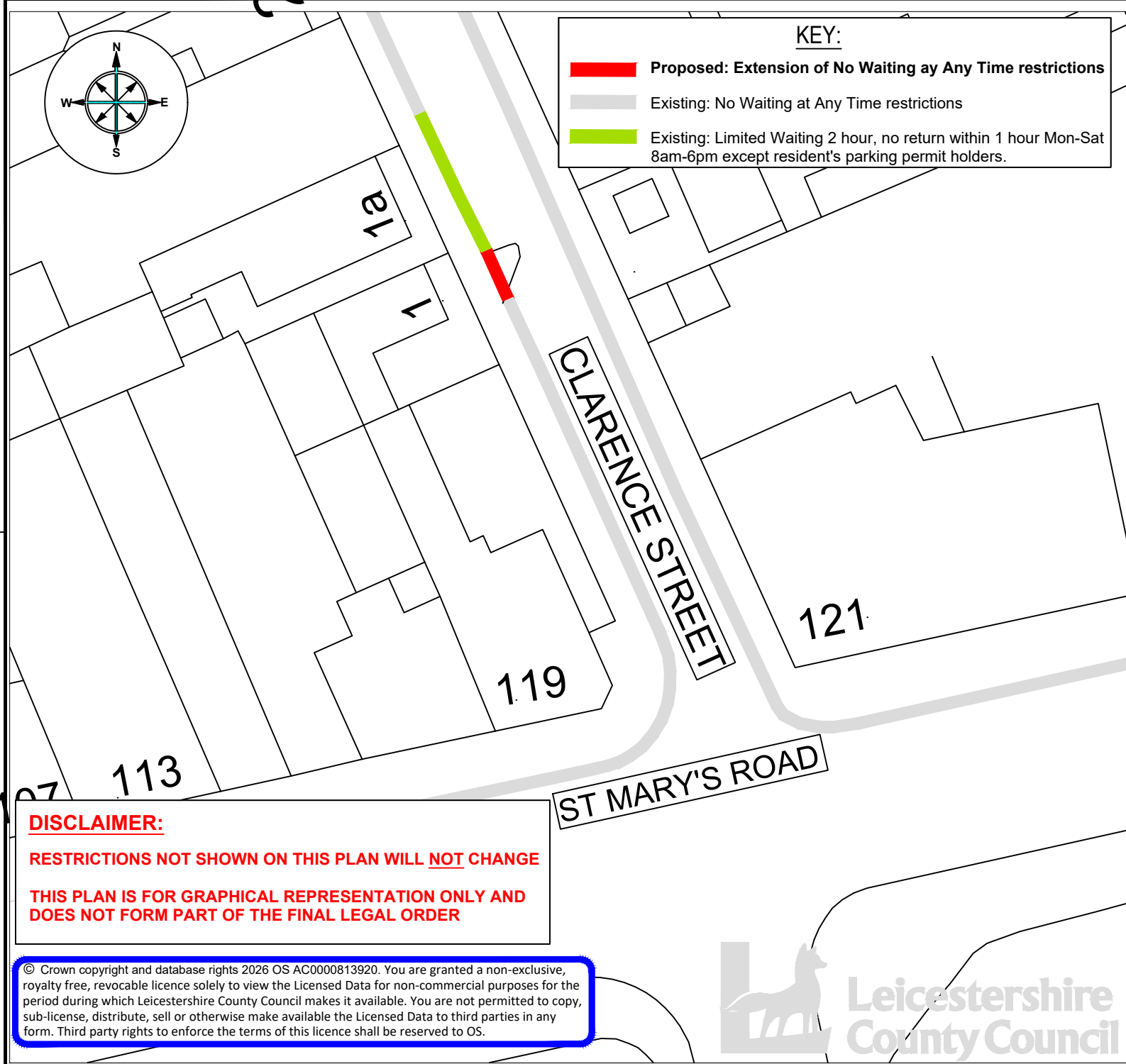

**IMPOSITION OF MOVING RESTRICTIONS AND EXTENSION OF NO WAITING  
AT ANY TIME RESTRICTIONS**

**STATEMENT OF REASONS**

Leicestershire County Council proposes to make the following Order:

1. To introduce a one-way northbound system on Clarence Street, Market Harborough, from its junction with St Mary's Road (A4304) to its junction with Albert Road.
2. To extend no waiting at any time restrictions along Clarence Street to facilitate the introduction of a one-way system.

The changes are intended to reduce congestion and improve safety at the signal-controlled junction of Clarence Street, St Mary's Road (A4304), and Kettering Road. Traffic modelling shows that, without intervention, this junction will experience severe delays under future traffic conditions. Making Clarence Street one-way will reduce the number of signal stages, improve junction efficiency and enable smoother traffic flow.

To facilitate the proposed one-way system, the existing give-way priority feature on Clarence Street will be removed. Therefore, it is necessary to extend the no waiting at any time restrictions to cover this area to prevent obstruction.

This scheme supports the Market Harborough Transport Strategy, Leicestershire's Local Transport Plan (LTP4), and the Local Cycling and Walking Infrastructure Plan by promoting sustainable travel, reducing congestion at pinch points, and improving network integration.

Additionally, an anomaly has been identified in the original Harborough Consolidation 2022 Order regarding the time period quoted for limited waiting on Clarence Street. The Order currently states a maximum waiting time of 1 hour, whereas the intended limited waiting restriction is 2 hours. This discrepancy requires correction to ensure the Order accurately reflects the restriction. This amendment is solely an order update with no changes on ground.

The proposals are shown in plans TM5207-MHTS/T1/1/A-B.

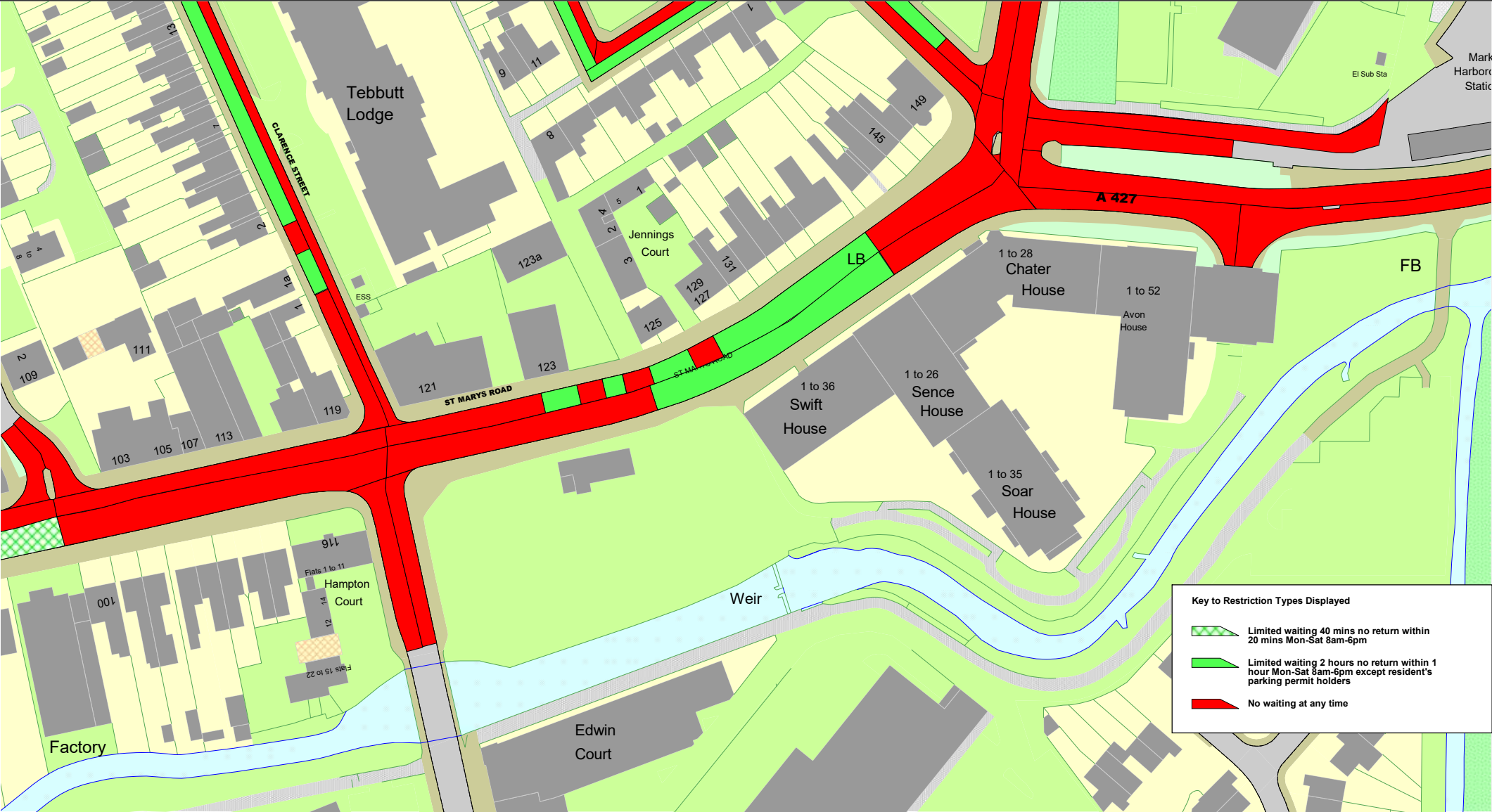
