THE LEICESTERSHIRE COUNTY COUNCIL hereby gives notice that it proposes to make an Order under Sections 1, 2, 4, 5, 19, 32, 35, 45, 46, 47, 49 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (“the Act”), and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, the effect of which will be:

To shorten the existing prohibition of vehicles restrictions within the Pedestrian & Cycle Zone on Cheapside, High Street, Market Place, Nottingham Street and South Parade, Melton Mowbray to 10am - 3pm, except for loading.

To update the imposition of a Pedestrian Zone at all times for the full length of Church Street. This is solely an order update, therefore there will be no change on site.

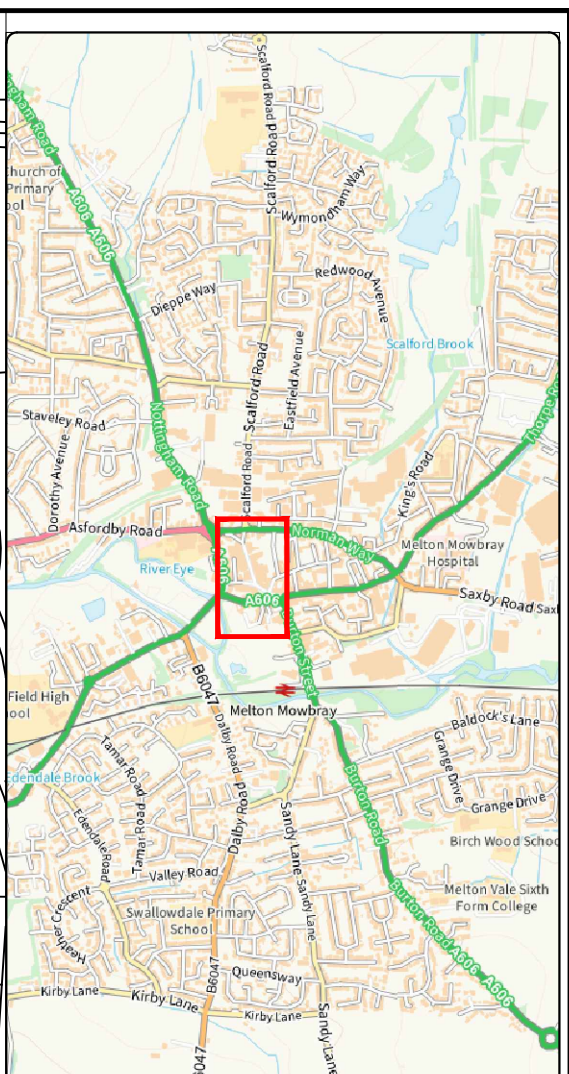
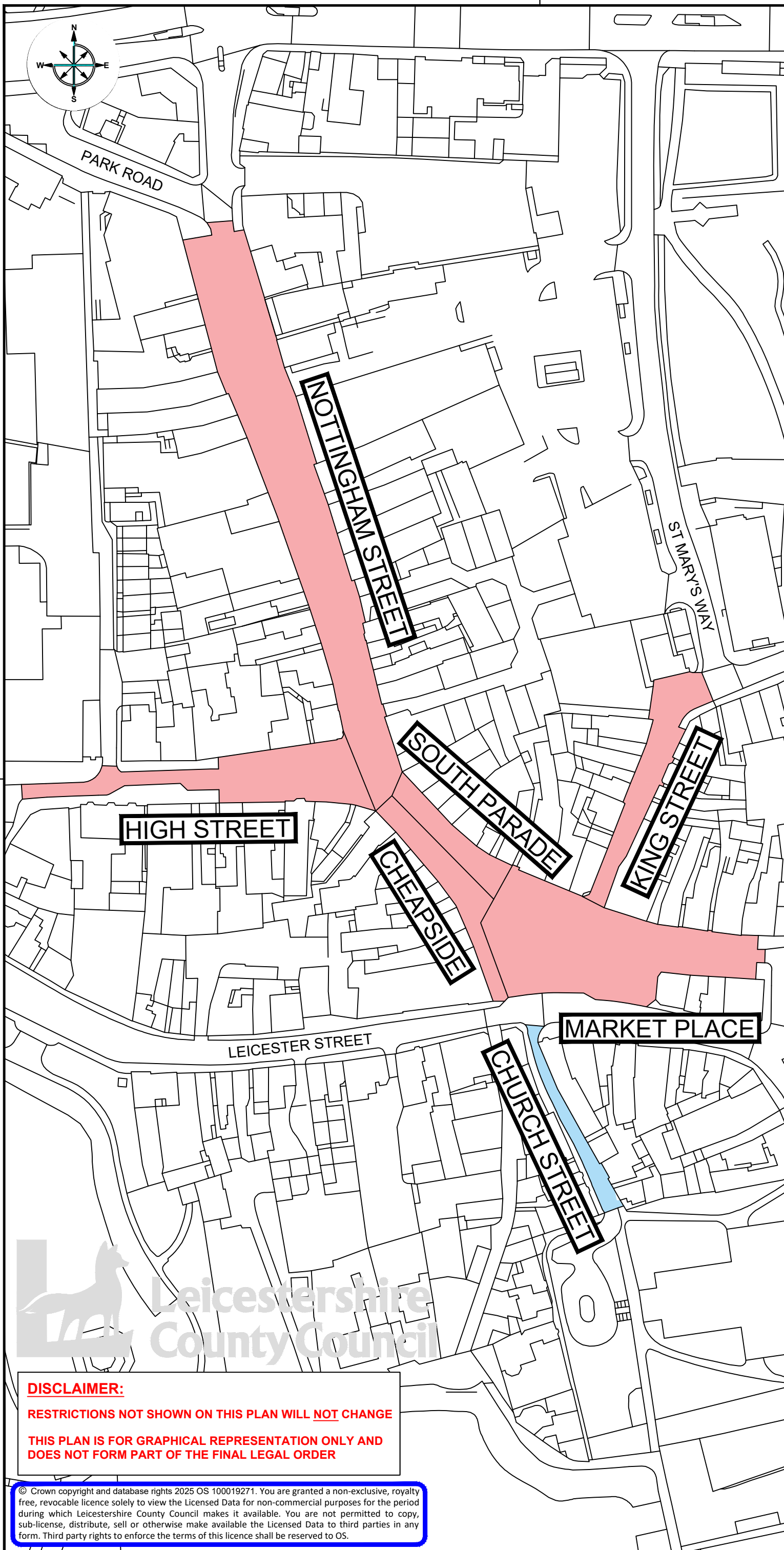

STATEMENT OF REASONS

Leicestershire County Council proposes to make this order on behalf of Melton Borough Council.

Following concerns raised by Melton Borough Council, Melton Mowbray Town Estate, town centre businesses and the market, we are proposing to shorten the prohibition of vehicles restrictions within the Pedestrian & Cycle Zone in Melton Mowbray to 10am - 3pm, except for loading.

Additionally, due to an irregularity discovered within the original Pedestrian Zone Order on Church Street, an update is needed to correct this anomaly. An imposition of a Pedestrian Zone at all times for the full length of Church Street. This is solely an order update, therefore there will be no change on site.

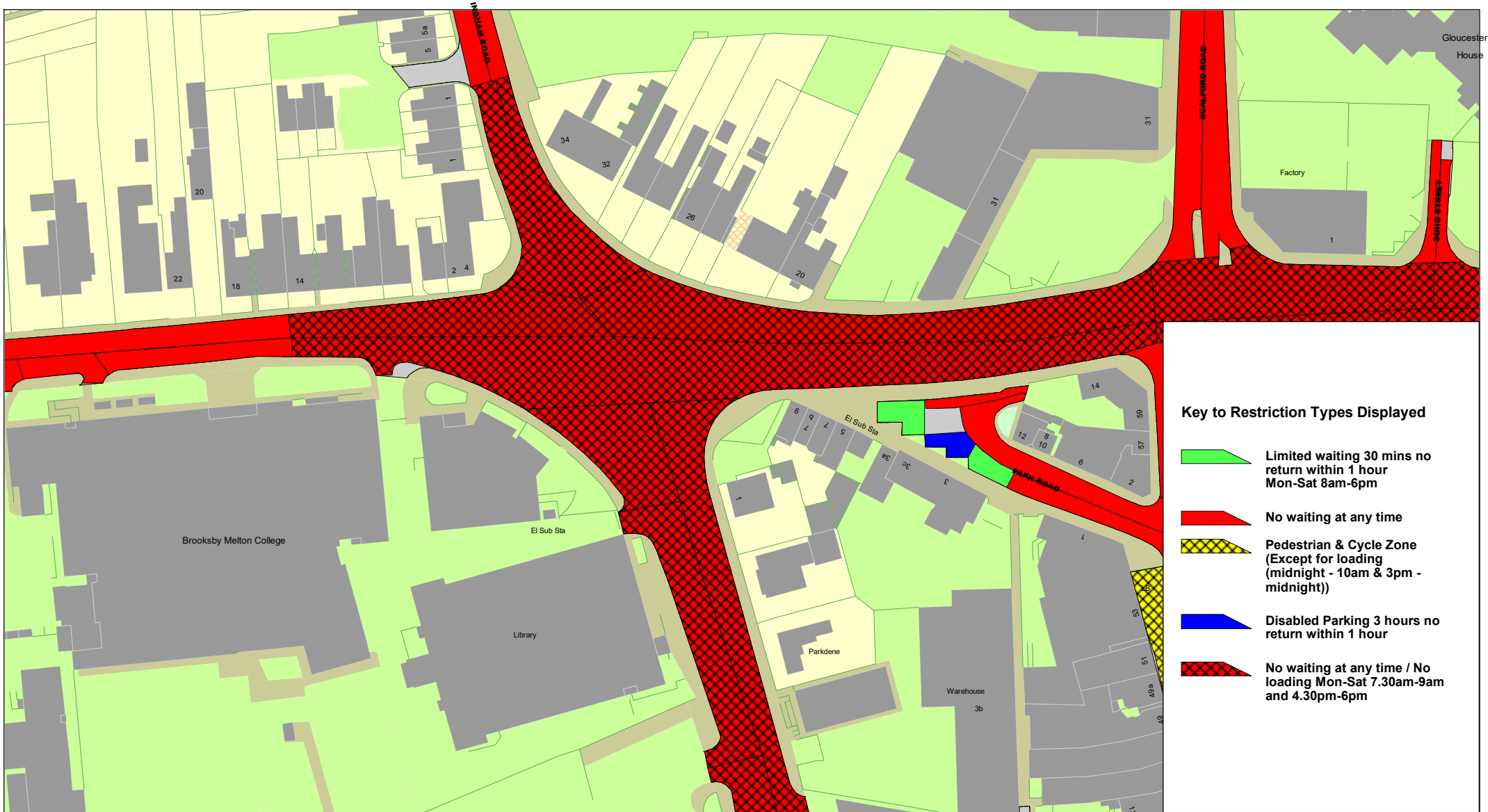

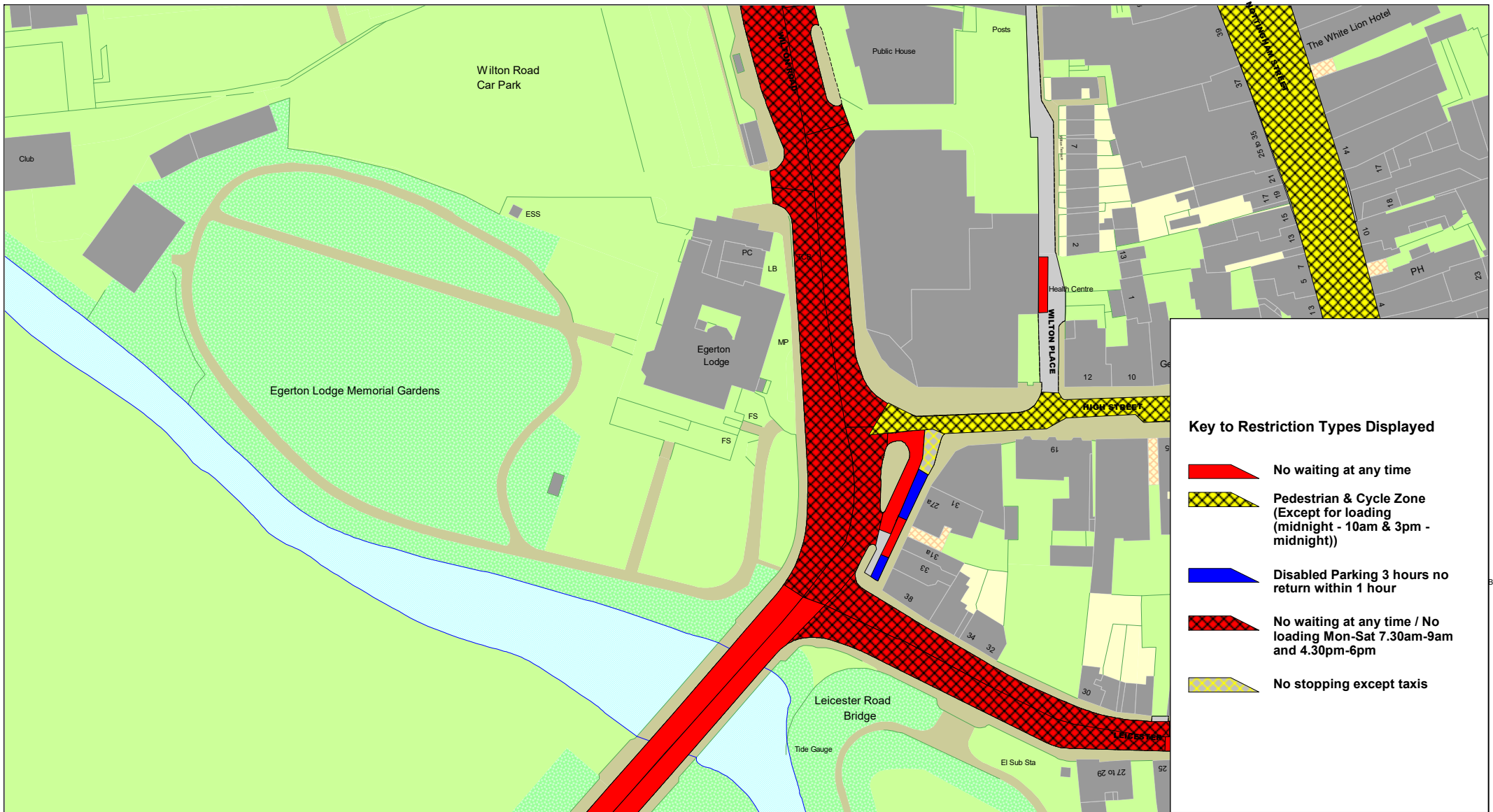

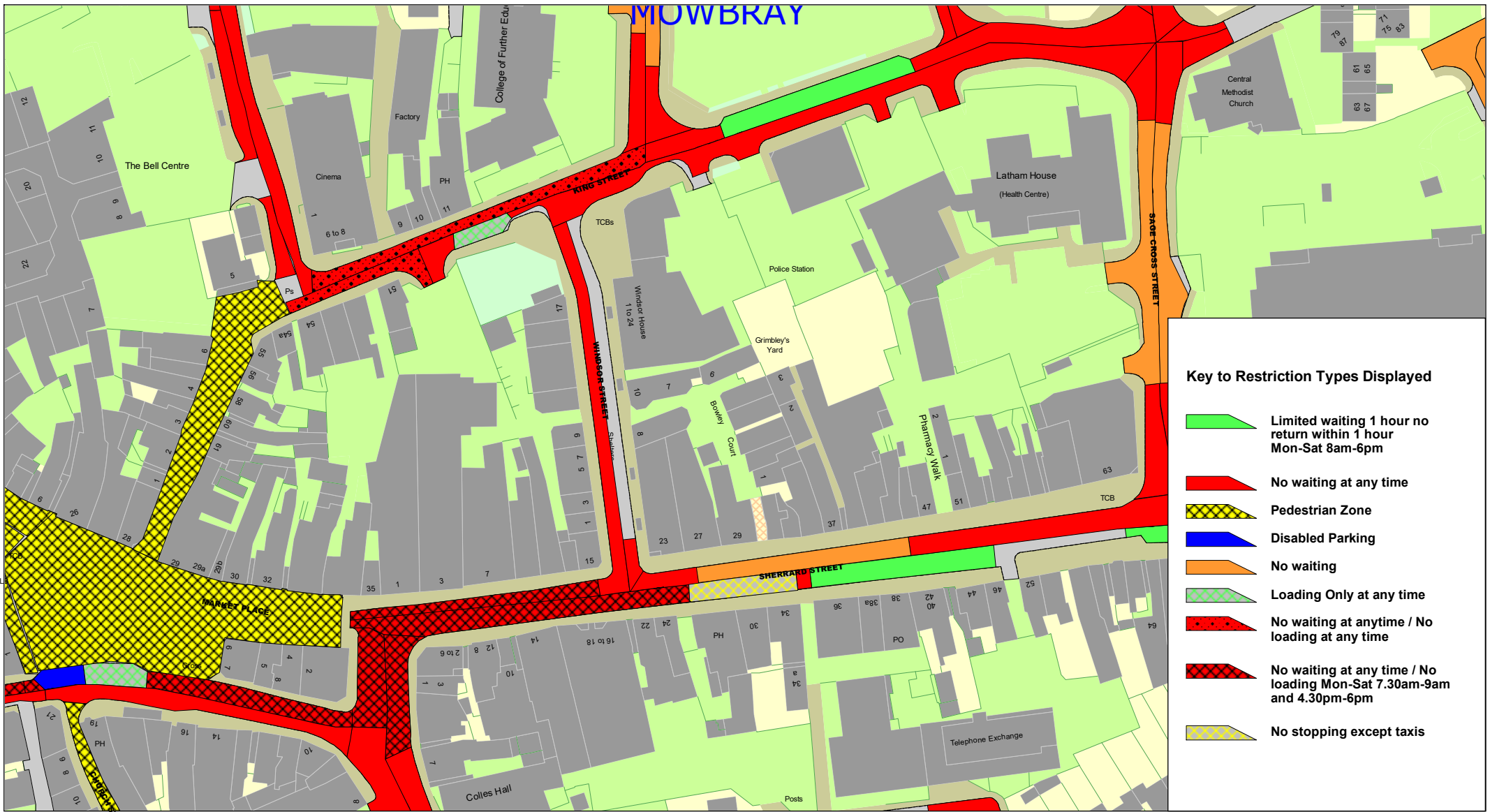
