THE LEICESTERSHIRE COUNTY COUNCIL hereby gives notice that it proposes to make an Order under Sections 1, 2, 4, 5, 19, 32, 35, 45, 46, 47, 49 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (“the Act”), and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, the effect of which will be:

To impose No Waiting at Any Time restrictions at the following locations:

- Acres Rise / Crossfield Drive, Melton Mowbray
- The Crescent, Melton Mowbray
- Mill Lane / High Street / Burgins Lane, Waltham on the Wolds
- Roseberry Avenue / North Street / Brook Crescent / Main Road Service Road, Asfordby Valley

STATEMENT OF REASONS

Leicestershire County Council proposes to make the following order.

Proposed No Waiting at Any Time restrictions at the following locations:

- Acres Rise / Crossfield Drive, Melton Mowbray
- The Crescent, Melton Mowbray
- Mill Lane / High Street / Burgins Lane, Waltham on the Wolds
- Roseberry Avenue / North Street / Brook Crescent / Main Road Service Road, Asfordby Valley

These restrictions are proposed at each location to tackle parking that is a hazard and obstructive to other road users and create a safe highway environment allowing for safe passage for all of its users.

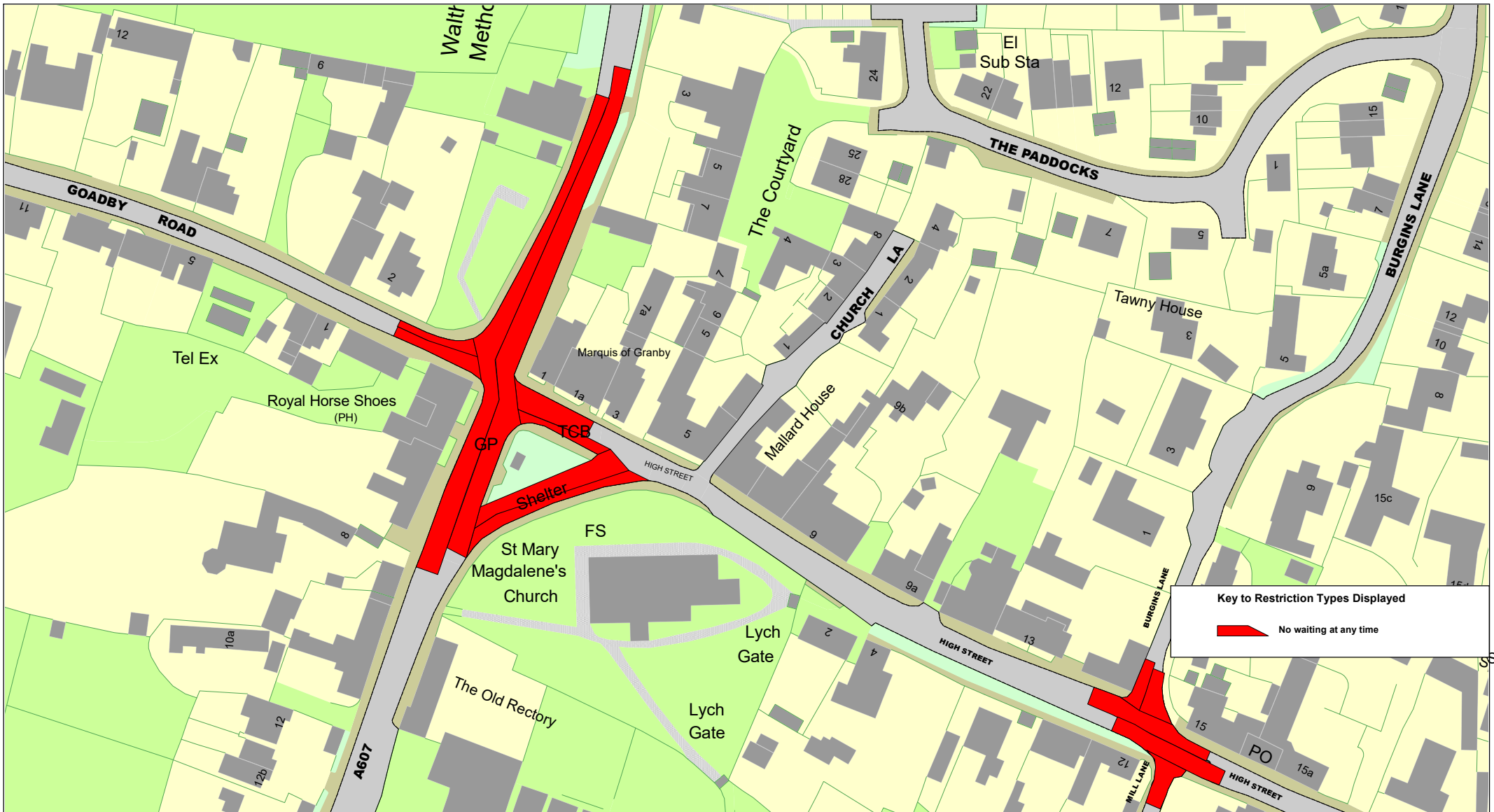

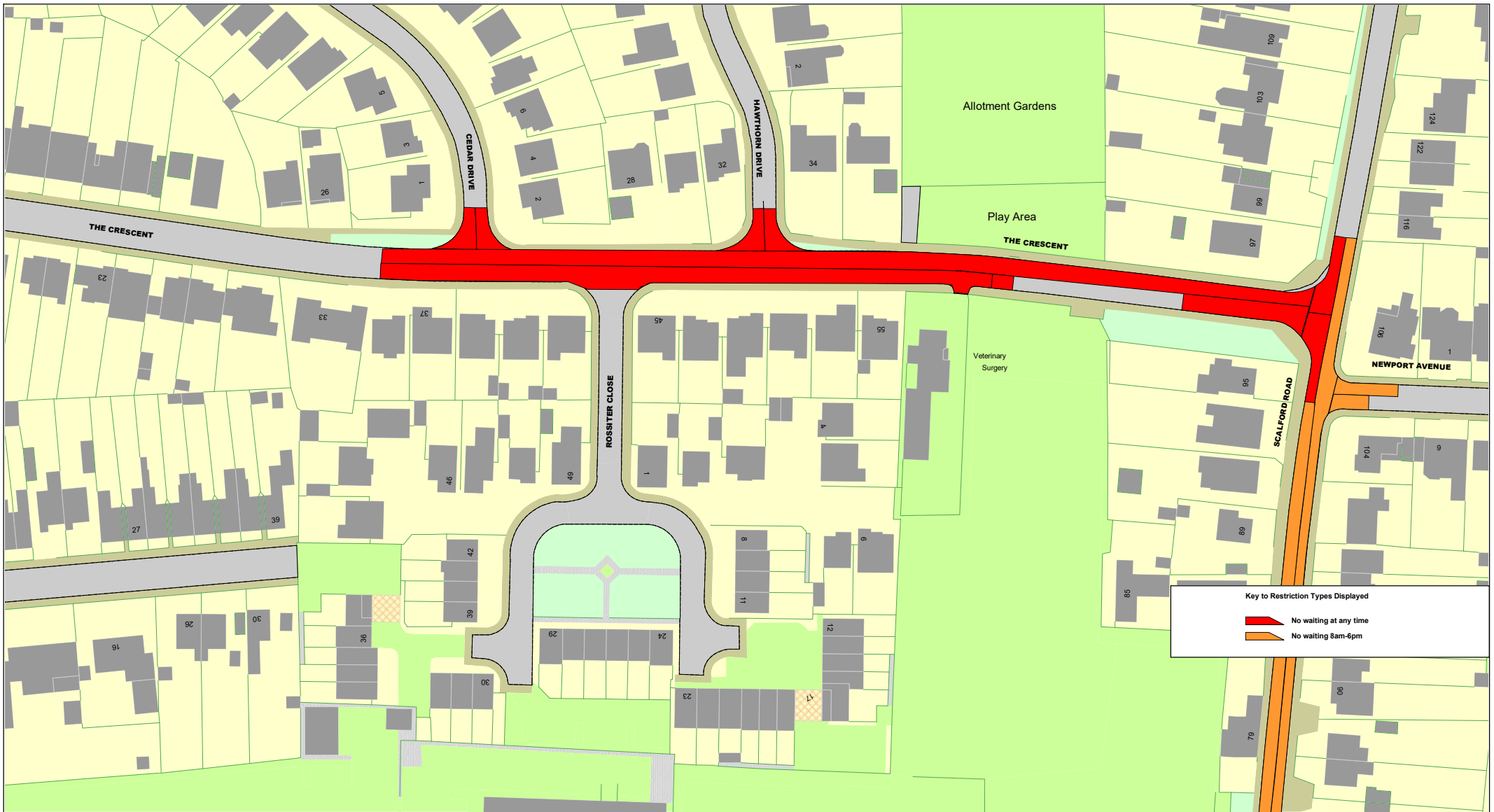

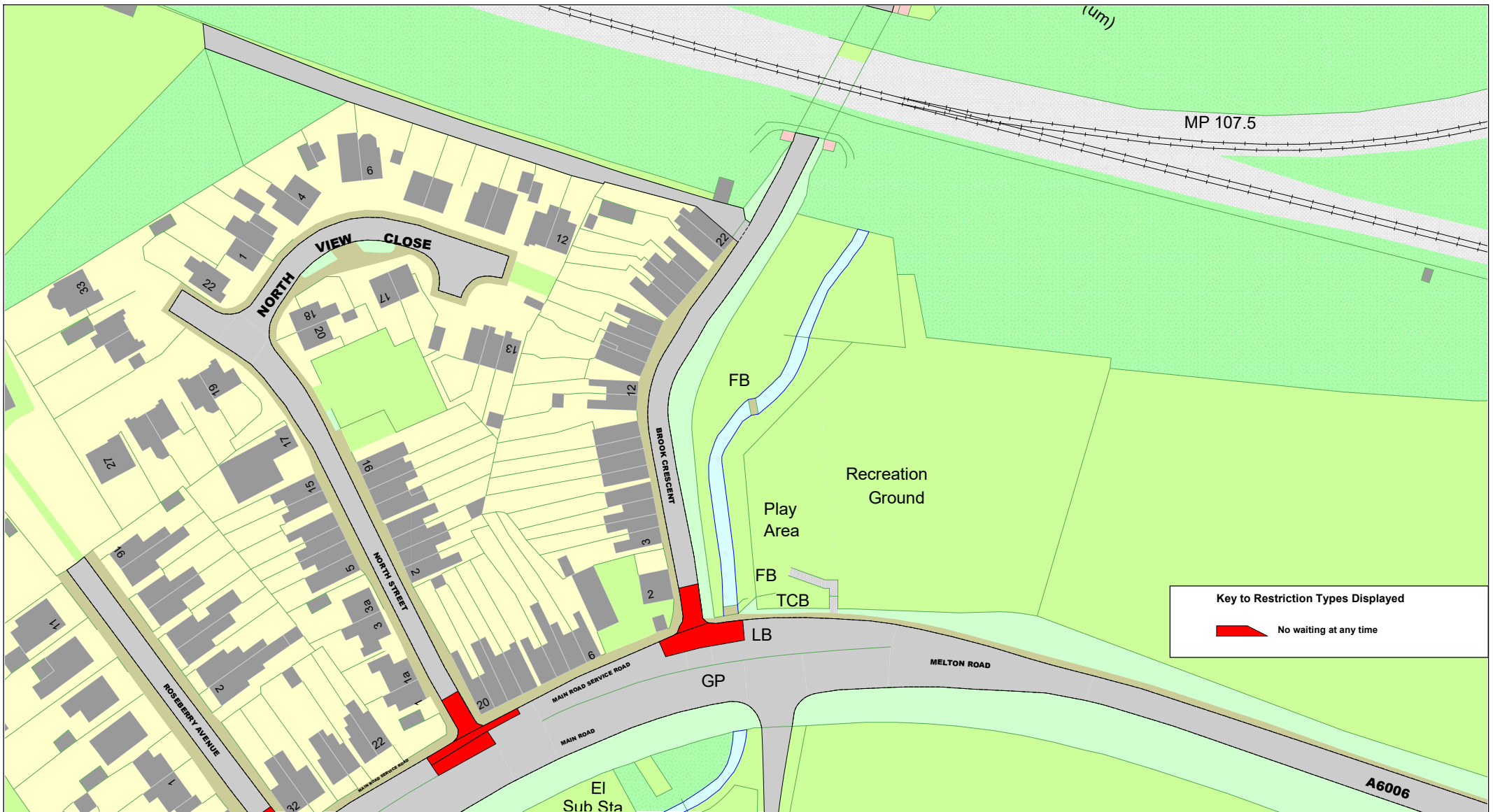
