**Desford Lane, Ratby** – In close proximity to the entrance to Desford Medical Centre.

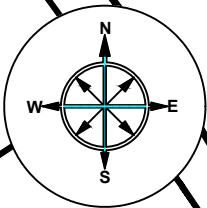

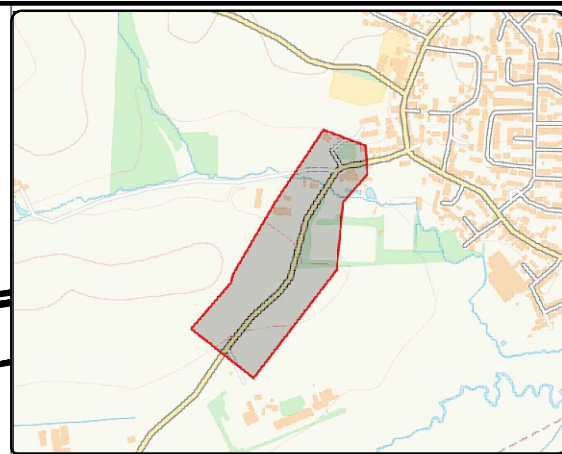
