

THE LEICESTERSHIRE COUNTY COUNCIL  
(VARIOUS ROADS, NANPANTAN, LOUGHBOROUGH,

(IMPOSITION OF 40 AND 50 MPH SPEED LIMITS) ORDER 2026

The Leicestershire County Council ("the Council") in exercise of its powers under Sections 5, 84 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers, after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby makes the following Order:-

1. This Order may be cited as "The Leicestershire County Council  
(Various Roads, Nanpantan, Loughborough, Borough of Charnwood)  
(Imposition of 40 and 50 MPH Speed Limits) Order 2026"
2. The Order shall come into force on the eighteenth day of May 2026.
3. The Order specified in Schedule 1 to this Order is hereby revoked in full.
4. No person shall drive any motor vehicle at a speed exceeding 40 MPH on the lengths of roads as specified in Schedule 2 to this Order.
5. No person shall drive any motor vehicle at a speed exceeding 50 MPH on the lengths of roads as specified in Schedule 3 to this Order.
6. The plan annexed to this Order and marked drawing number TM5187/T1/1/CONSULT is for identification purposes only.

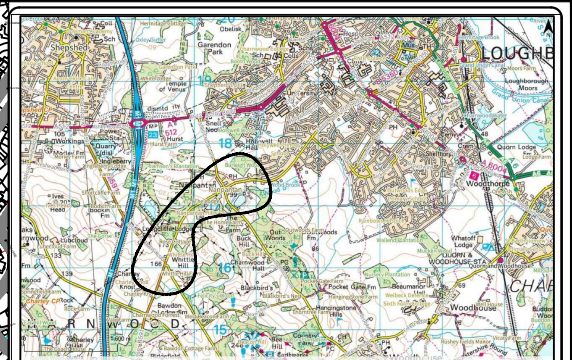
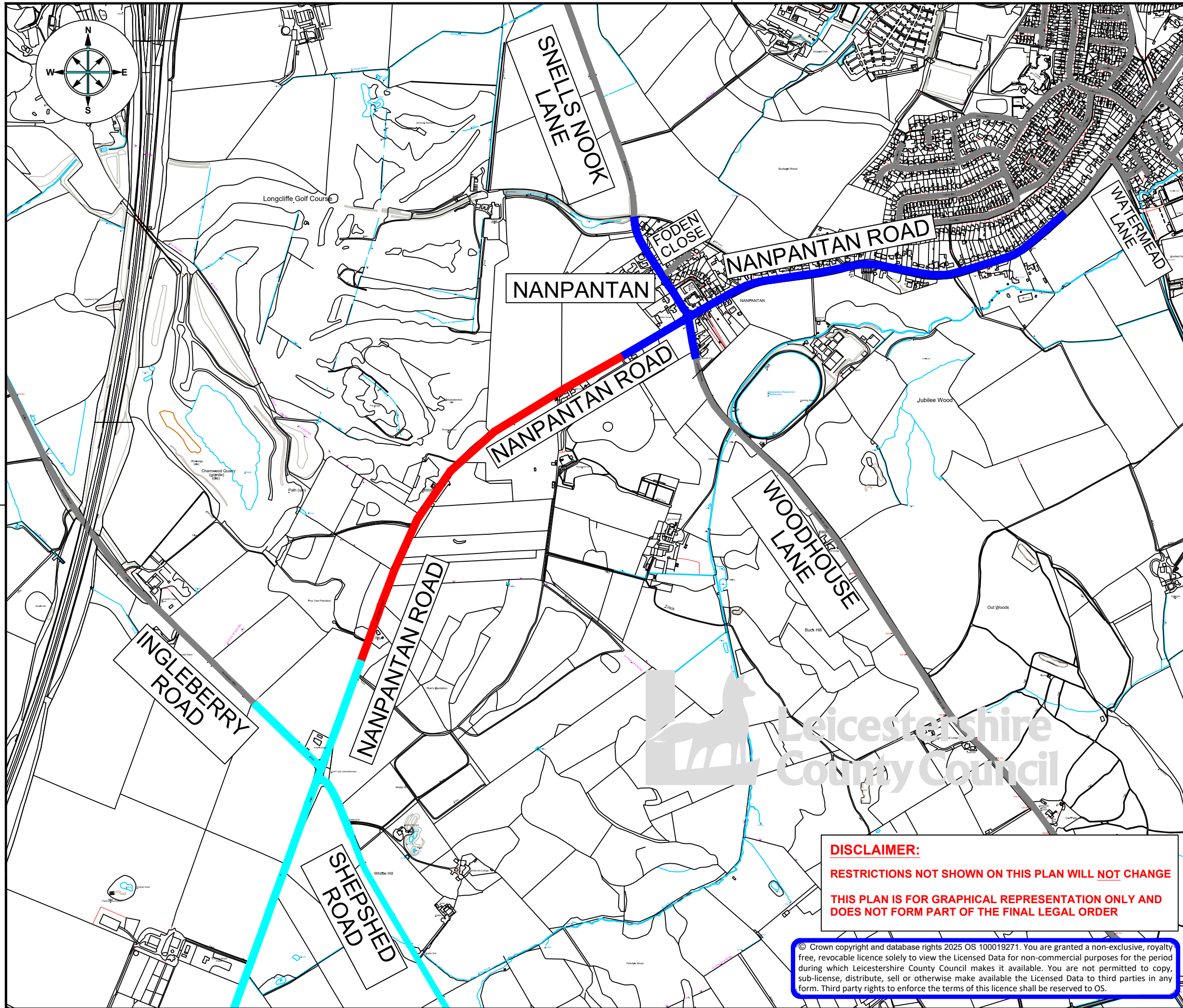
