THE LEICESTERSHIRE COUNTY COUNCIL hereby gives notice that it proposes to make an Order under Sections 1, 2, 4, 5, 19, 32, 35, 45, 46, 47, 49 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (“the Act”), and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, the effect of which will be:

No Waiting at Any Time restrictions for the entirety of Hill Street, Ashby de la Zouch and for parts of Tamworth Road, Cambrian Way, Lower Packington Road, Upper Packington Road, and From Lower Packington Road to Ashby Road, Ashby de la Zouch.

No Waiting at Any Time and No Loading Mon-Sat 7:30am-9am and 4:30pm-6pm restrictions on part of Market Street, Ashby de la Zouch.

Additionally, due to irregularities discovered within the original Traffic Regulation Order for Waiting Restrictions on Market Street and Brook Street, an update is needed to correct these anomalies. This is solely an order update, therefore there will be no change on site.

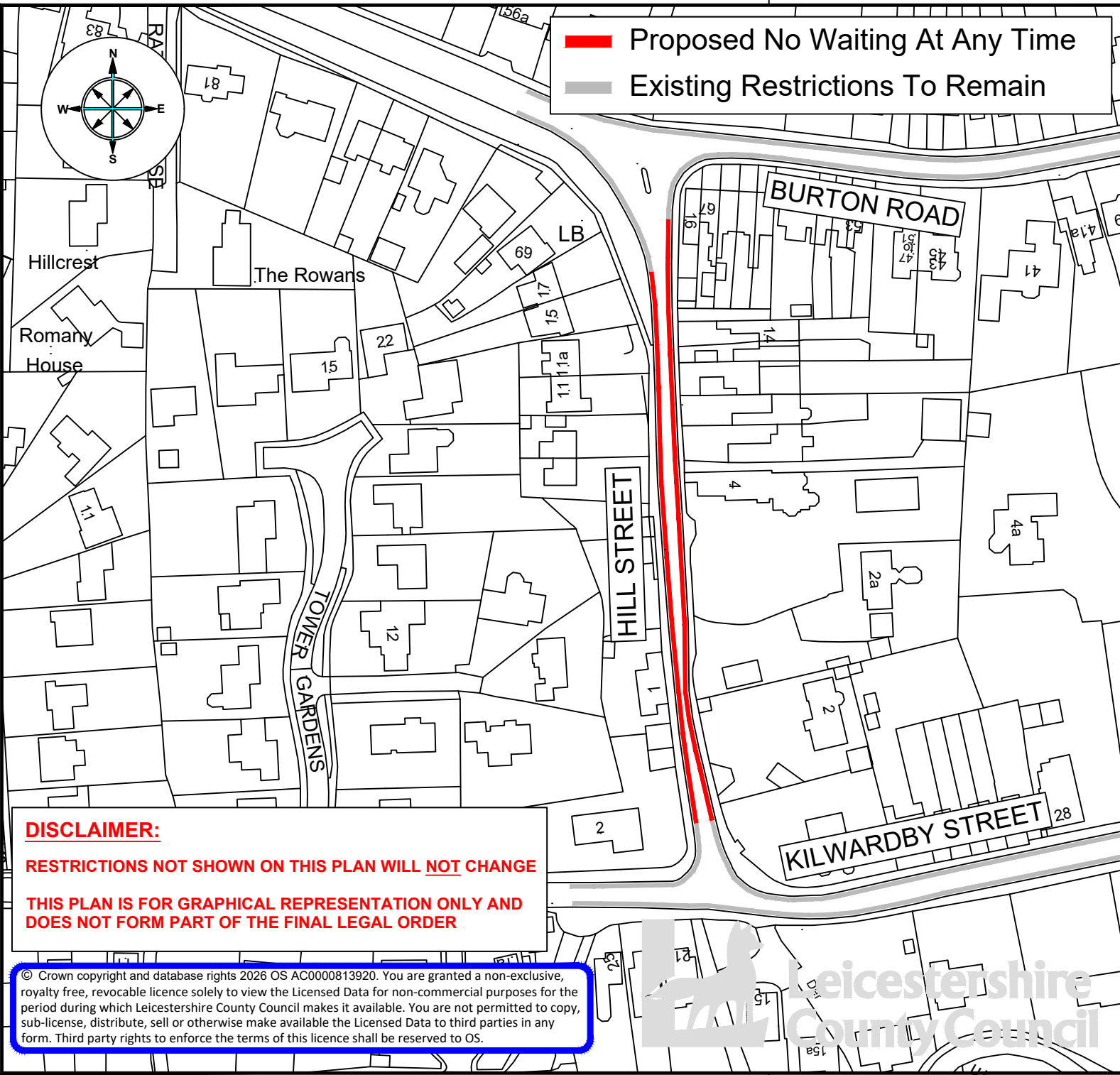

PROPOSED WAITING RESTRICTIONS

STATEMENT OF REASONS

In conjunction with both the Local County Councillor and Ashby Town Council, Leicestershire County Council is proposing to introduce the following waiting restrictions:

No Waiting at Any Time restrictions for the entirety of Hill Street, Ashby de la Zouch and for parts of Tamworth Road, Cambrian Way, Lower Packington Road, Upper Packington Road, and From Lower Packington Road to Ashby Road, Ashby de la Zouch.

No Waiting at Any Time and No Loading Mon-Sat 7:30am-9am and 4:30pm-6pm restrictions on part of Market Street, Ashby de la Zouch.

The order is being introduced on the grounds of preventing parking which is impeding the expedient movement of traffic.

Additionally, due to irregularities discovered within the original Traffic Regulation Order for Waiting Restrictions on Market Street and Brook Street, an update is needed to correct these anomalies. This is solely an order update, therefore there will be no change on site.
