High Street, Bottesford – at the crossroads with Barkestone Lane and Albert Street.

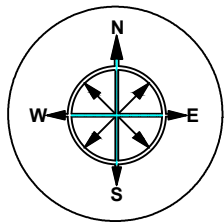

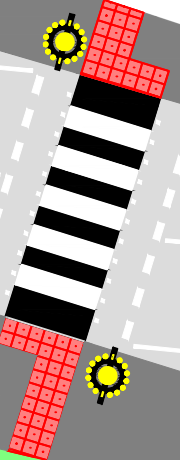


ALBERT STREET

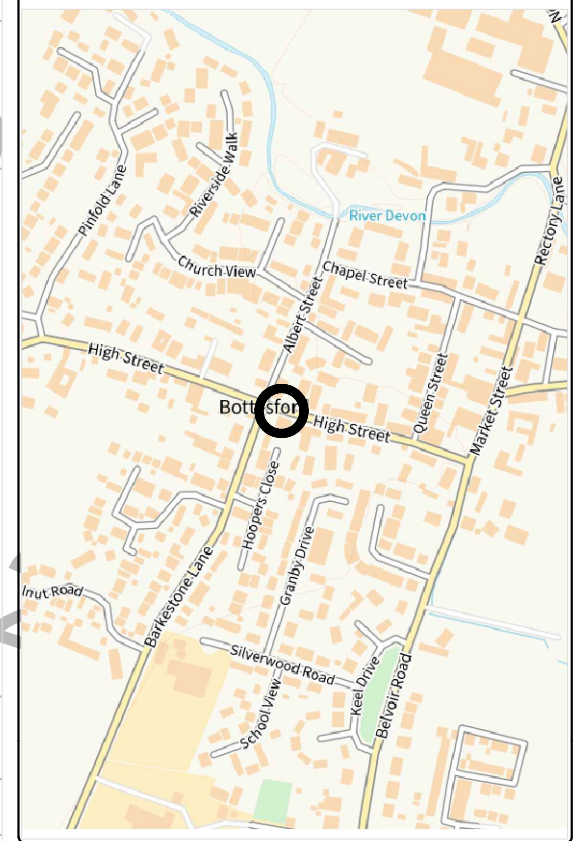
Proposed Zebra Crossing

**STATEMENT OF REASONS**

Leicestershire County Council proposes to implement a Zebra Crossing facility on High Street, Bottesford.

The Zebra Crossing will provide connectivity and a safe location to cross for pedestrians within the village accessing local amenities.
