THE LEICESTERSHIRE COUNTY COUNCIL hereby gives notice that it proposes to make an Order under Sections 5, 81, 82(2), 83(2) and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act"), and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, the effect of which will be:

To impose a 40-mph Speed Limit on parts of Zouch Road, Hathern (A6006) and Main Street, Zouch (A6006)

PROPOSED 40MPH SPEED LIMIT

STATEMENT OF REASONS

Leicestershire County Council proposes to make the following order.

To facilitate the newly constructed bridge at the Leicestershire/ Nottinghamshire border between Hathern and Zouch it is proposed to reduce the existing national speed limit and introduce a 40mph speed limit on Zouch Road, Hathern (A6006) and Main Street, Zouch (A6006).

This speed limit order is being introduced on the grounds of road safety in order to achieve compliance with the new vertical and horizontal alignment of the bridge and the associated visibility requirements.

The proposals are as shown in consultation drawing number TM5266.T1.1.1.

The Leicestershire County Council ("the Council") in exercise of its powers under Sections 5, 81, 82(2), 83(2) and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers, after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby makes the following Order:-

1. This Order may be cited as "The Leicestershire County Council (Zouch Road, Hathern (A6006) and Main Street, Zouch (A6006), Borough of Charnwood) (Imposition of a 40mph Speed Limit) Order 202"

3. No person shall drive any motor vehicle at a speed exceeding 40 MPH on the lengths of roads as specified in the Schedule to this Order

From the Leicestershire / Nottinghamshire County Boundary (Centre Line of Zouch Bridge) to a point 110m east of the County Boundary
