IMPOSITION OF DE-RESTRICTION TO NATIONAL SPEED LIMIT) ORDER 2026

The Leicestershire County Council ("the Council") in exercise of its powers under Sections 81, 82, 83, 84 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers, after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby makes the following Order:-

1. This Order may be cited as "The Leicestershire County Council (Various Roads, Various Parishes, the District of North West Leicestershire) (Revocation and Imposition of 30 MPH and 40 MPH Speed Limits and Imposition of De-Restriction to National Speed Limit) Order 2026"
2. The Order shall come into force on the twenty-eighth day of August 2026.
3. The Orders specified in Schedule 1 to this Order are hereby revoked in full.
4. The Orders specified in Schedule 2 to this Order are hereby revoked in part insofar as they relate to the lengths of road described in that Schedule.
5. No person shall drive any motor vehicle at a speed exceeding 30 MPH on the lengths of roads as specified in Schedule 3 to this Order.
6. No person shall drive any motor vehicle at a speed exceeding 40 MPH on the lengths of roads as specified in Schedule 4 to this Order.

7. Those lengths of road as specified in Schedule 5 to this Order shall cease to be restricted roads for the purposes of Section 82 of the Act.

New Road Swannington and Coleorton from its junction with Loughborough Road (A512) to its junction with Nottingham Road, a distance of approximately 205 metres, its entire length.

Hull Lane Swannington and Coleorton from its junction with Zion Hill/Nottingham Road to its junction with Loughborough Road (A512) for a distance of approximately 230 metres, its entire length.

Anchor Lane Swannington and Coleorton from its junction with Loughborough Road (A512) to its junction with Nottingham Road for a distance of approximately 431 metres, for its entire length.

Zion Hill (B587) Coleorton/Gelsmoor Road, Worthington from its junction with Nottingham Road in a north westerly direction to a point 116 metres south east of Aquaduct Road a distance of approximately 667 metres.
