To amend the existing mandatory School Keep-Clear markings outside the entrance to Hinckley Parks Primary School, Butt Lane, Hinckley. The current mandatory School Keep Clear restrictions are in force '*Mon-Fri 8am – 5pm*'

All mandatory keep clear restrictions are uniformed across Leicestershire for consistency and to enable regular enforcement with our camera enforcement vehicle.

The amendment proposes to change the existing restrictions to Monday to Friday 8am – 4pm in-line with all other school markings across Leicestershire and continue to create a safe environment outside of the school gates.

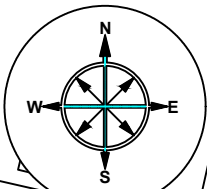

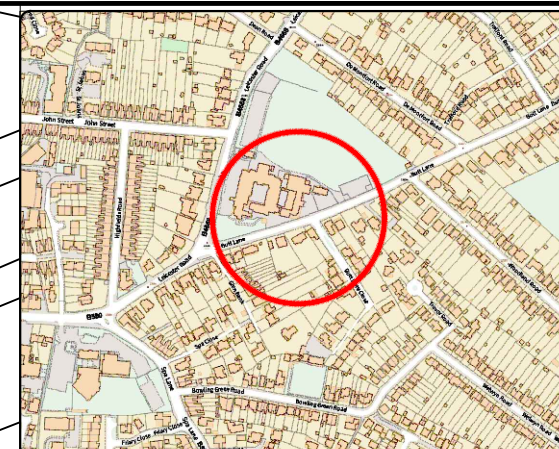

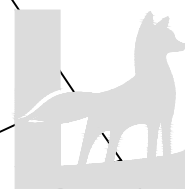
