Permit availability:

Residents' parking enables permit holders to park within the on-street parking bays in a particular zone without restriction. It is provided to deter non-residential vehicles from parking and causing congestion.

Frequently Asked Questions:

What does a permit allow?

A permit allows you to park a vehicle, without time restriction, within the designated zone during the hours of operation; between Monday and Friday. Parking would otherwise be prohibited.

Are permit holders guaranteed parking within the zone?

Spaces are not reserved exclusively for each permit holder, so a parking space is not guaranteed. There is also no guarantee that any spaces available will be adjacent to the property address. However, with the removal of parking by non-permit holders, there is a much greater availability of parking space.

Who qualifies for a Workplace' parking permit?

Business' with a postal address in the workplace' zone area. Up to ten 'Generic' permits may be issued for each postal address. This permit can be used in any vehicle.

For how long are workplace' parking permits valid?

All workplace' parking permits are valid for 12 months from the date of issue. All permits must be returned to Leicestershire County Council if you vacate your premises before they expire.

What happens if I don't display a valid permit?

Parking a vehicle in workplace' parking zone, without a valid permit, may result in the issue of a Penalty Charge Notice.

How do I apply for a workplace' parking permit?

Application forms may be downloaded from the Leicestershire County Council website, 'Parking Matters', or are available on request from the address at the bottom of this page.

Each applicant needs to complete the form and return it with:

• Proof of business address

For proof of business address, letter headed paper is acceptable.

If proof is not available please contact the Residents Parking Team.

No refunds are available on permits once issued

How are workplace' parking permits issued?

Upon receipt of a valid application, your workplace' parking permit will be posted to you, we aim to issue permits within 5 working days of receipt of the valid application.

What if I have Visitors?

There are no permits available for visitors to park in the workplace' parking zone, however, the 'Generic' permits issued for each postal address can be transferred between 'Visitors' vehicles.

How do I know what the current charges are?

The current charges are available on the website, or on request.
