The Forum brings together representatives of land managers, users and other relevant fields or areas of interest to watch over and help shape the future of footpaths, bridleways, byways, open access land and other green spaces.

The Forum is an independent body that advises Leicestershire County Council, and other relevant bodies, on how people can make the most of opportunities for getting out and about in the great outdoors.

If you feel that, in a voluntary capacity, you could contribute to the Forum's work, this pack tells you more about the Forum and how you can become involved as a member.

An outline of the Leicestershire Local Access Forum

What is the Local Access Forum?

The Leicestershire Local Access Forum (LLAF) is an independent official body, set up as a result of the Countryside and Rights of Way Act 2000, and exists to represent the interests of everyone in the County concerned with public rights of way (footpaths, bridleways and byways) and access to the countryside.

Leicestershire has a network of 'definitive paths' totalling over 3000 kms (the equivalent of a path from Leicester to well beyond Moscow) and more than 100 Open Access areas. There are also permissive paths, country parks and other opportunities to walk and ride.

What is the Access Forum for?

The main role of the Forum is to advise all levels of local government, national government and other agencies by commenting officially on policy proposals and any other access issues. In doing this it focuses particularly on:

- improving public access to land for outdoor recreation.
- encouraging the enjoyment and understanding of the countryside.
- considering the needs and concerns of land managers, tenants and owners.
- enhancing and conserving the natural environment.
- developing the rights of way network, working through the Rights of Way Improvement Plan (ROWIP).
- broadening opportunities to use the rights of way network considering especially those who, at present, may feel excluded.

What else is expected of the Forum?

Whilst giving advice the Forum is expected to:

- Develop a constructive and inclusive approach to the improvement of recreational access to the countryside.
- Respect local circumstances and different interests while following national guidance.
- Act as a bridge between different interest groups and seek a consensus wherever possible.

Who does the Access Forum advise?

The Forum is a 'statutory advisory body' which may comment officially on relevant matters, giving its advice to various public agencies including:

- the County and District Councils
- Town and Parish Councils
- Central and Regional Government
- Highways Authorities
- Natural England

The Forum may also advise other conservation and environmental bodies.

Who does the Forum represent?

The Forum is made up of local people. Individual members represent areas or fields of interest rather than any particular organisation of which they might be a member. The Forum has a maximum of 22 members, up to 3 of whom will be County Councillors. Members cover different interests, representing people who either:

- enjoy countryside access activities, such as walkers, horse riders, orienteers, runners, cyclists, motor users, climbers and wildlife or heritage enthusiasts.
- own, farm and manage the land, including landowners, tenants, farmers and other occupiers.
- or have an interest in other aspects such as local community or conservation issues, promoting health, the environment, public transport or tourism.

Who appoints Forum members?

Responsibility for appointing Forum members is with the County Council. The Council ...

- aims to ensure there is a balance between the different fields or areas of interest.
- seeks people who can contribute positively and bring wider experience to the work of the Forum, whether or not they are land managers or committed rights of way users.
- recognises the need for the Forum to contain a broad base of skills and views, and for its membership to reflect the spectrum of all those who live and work in Leicestershire.

Does the Forum take up individual issues?

The Forum focuses upon broader concerns and does not normally comment on individual issues. However, it is able to raise issues of a more general nature with Council officers, and regularly monitors the work of the County Council's Rights of Way Service.

How often does the Forum meet?

There are 2-4 main meetings a year plus any sub-group meetings. Members may also attend site visits, workshops, training events and conferences as appropriate.

Main Forum meetings are normally on weekday evenings, sometimes preceded by an optional afternoon workshop session. Site visits and training may be at other times.

Are Forum members paid?

No. All members are volunteers and give their time freely. However, members can claim reasonable out of pocket expenses incurred as part of Forum duties including travel, subsistence, childcare or care of other dependents. After being appointed procedures for claiming, mileage rates and subsistence limits will be outlined, and claim forms provided.

Who can attend a meeting of the Forum?

Anyone. All full Forum meetings are open to the general public as observers.

How to access agendas and minutes of Forum meetings?

- 3. To contribute positive ideas and actively take part in discussions within the Forum in an objective and constructive manner.
- 4. To be respectful and understanding of the views of other Forum members.
- 5. To represent the full range of issues related to the member's individual field(s) of interest, not only those of any particular organisations connected with that interest.
- 6. To contribute positively to Forum discussions within meetings including subgroups.
- 7. To be willing to undertake and participate in appropriate training, including possible travel as required to other locations.
- 8. To engage with community contacts to publicise the work of the Forum, and gather feedback on current issues to contribute to the Forum's discussions.
- 9. In all contacts to present a good image of the Local Access Forum as well as maintaining constructive relationships.
- 10. To abide by the rules and guidance as set out in the Terms of Reference and other protocols agreed by the Forum.
