THE LEICESTERSHIRE COUNTY COUNCIL (THORPE ROAD, MELTON MOWBRAY AND WALTHAM ROAD, WALTHAM ON THE WOLDS BOROUGH OF MELTON) (IMPOSITION OF A RESTRICTED ROAD AND 40 MPH SPEED LIMIT) ORDER 2019

The Leicestershire County Council ("the Council") in exercise of its powers under Sections 5, 81, 82(2), 83(2), 84 and part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers, after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby makes the following Order:-

- This Order may be cited as "The Leicestershire County Council (Thorpe Road, Melton Mowbray and Waltham Road, Waltham on the Wolds, Borough of Melton) (Imposition of a Restricted Road and 40 MPH Speed Limit) Order 2019" and shall come into force on the twenty eighth day of October 2019.
- The Leicestershire County Council (40mph Speed Limit) (No 2) Order
 1979 is hereby revoked in part as specified in Schedule 1 to this Order.
- 3. That length of road as specified in Schedule 2 to this Order shall become a restricted road for the purpose of Section 81 of the Act.
- No person shall drive any motor vehicle at a speed exceeding 40 MPH
 on the length of road as specified in the Schedule 3 to this Order.
- The plan annexed to this Order and marked drawing number
 TM4528/T1/1 is for identification purposes only.

SCHEDULE 1

REVOCATION IN PART

The Leicestershire County Council (40mph Speed Limit) (No 2) Order 1979

That length of Thorpe Road (A607) which extends from its junction with Belvoir Street for a distance of 680 yards in a north-easterly direction measured along the said road and any other Order of Statutory Instrument on this stretch of road.

SCHEDULE 2

IMPOSITION OF A RESTRICTED ROAD (30mph)

Thorpe Road, Melton Mowbray

From its junction with Belvoir Street to a point 227 metres north-east of its junction with Belvoir Street.

SCHEDULE 3

IMPOSITION OF 40 MPH SPEED LIMIT

Thorpe Road, Melton Mowbray and Waltham Road, Waltham on the Wolds

From a point 227 metres north-east of its junction with Belvoir Road, Melton Mowbray to a point 327 metres north-east of its junction with Lag Lane, Thorpe Arnold.
