### **1. Introduction**

- 1. This Policy explains the Local Authority's reasons and processes for the recoupment of costs from schools for children who, by reason of illness or poor health, are unable to attend a school and who are supported by the Authority to receive education through an alternative provider
- 2. This Policy is intended to operate in conjunction with the Framework agreement for the provision of Autism Outreach and Children with Medical Needs Support Services. The Council will commission all its services for children with medical needs through this framework to ensure a consistent and high-quality educational provision for all young people.
- 3. The revised policy was shared with Schools' Forum in September 2018. The forum noted the current position for CMN provision. The Forum gave its approval, in principle, to the recovery from Leicestershire Schools of the costs of educational provision to children with medical needs, provided always that the support to those children has been provided by the Council.

# 2. Legal Context

- 5. This Policy arises from, and is consistent with, the requirements of <u>Section 19</u> of the Education Act 1996 which requires that Local Authorities make arrangements for the provision of suitable education for children of compulsory school age who, because of illness, would otherwise not receive suitable education.
- 6. The Council is required to have regard to guidance issued by the Secretary of State for Education under <u>Section 19</u> of the Education Act 1996. The relevant Guidance is entitled "*Ensuring a good education for children who cannot attend school because of their health needs*". Materially, the <u>Guidance states as follows</u>:

"21. In all cases, effective collaboration between all relevant services (LAs, CAMHS, NHS, schools and, where relevant, school nurses) is essential to delivering effective education for children with additional health needs. Service level agreements and/or multi-agency forums may aid this process."

- 7. Further the Council also has a separate statutory duty to make arrangements to <u>promote co-operation</u> between the Council and bodies *(such as schools)* who exercise functions in relation to children with a view to improving the well-being of children in the authority's area so far as relating to education, training and recreation.
- 8. Under <u>equality legislation</u> both the Council and Schools must not discriminate against people with disabilities in the way they provide education or afford access to it.
- 9. In accordance with applicable regulations, this Policy was finalised and adopted following consultation with the Leicestershire Schools Forum.

# **3. Application of This Policy**

- 10. This Policy covers all publicly maintained schools including academies that require alternative education providers to be arranged by the Local Authority for children with medical needs.
- 11. Schools and academies may choose to make their own arrangements directly with education providers without the involvement and financial support of the Local Authority. In such circumstances, the Council will not then seek to recoup any monies which would otherwise be recoverable under the terms of this Policy.

#### 4. What Does This Policy Propose?

- 12. This Policy proposes to recover the cost of any educational provision arranged on behalf of schools by the Local Authority whilst a child or young person is prevented from attending school due to any medical condition (regardless of whether that inability to attend school is due to a physical or mental condition).
- 13. The charges to be recovered by the LA will be levied from the first day of any provision arranged by the LA and will continue until the respective pupil returns to their usual education in the school.

### **5. When Does This Policy Apply From?**

- 14. This policy will be applied from October 2021 for all new and all existing referrals and contracts held by the Council.
- 15. The policy is intended to operate in conjunction with the Council's procedures for dealing with children with medical needs, <u>found here</u>.

# 6. Policy Scope

16. The Policy covers recoupment arrangements for children and young people of statutory school age who receive education provision due to medical needs and are unable to attend their normal educational setting.

# **7. Objectives of This Policy**

- 17. The main purpose of this policy is to set out the arrangements in recovering the average per pupil funding for alternative provision currently commissioned by the Council for children with medical needs, as agreed through Schools Forum.
- 18. The recoupment policy forms part of a wider inclusive/local offer for young people with medical needs; that enables access to a tiered approach with the ethos of providing the right level of support whilst enabling reintegration back in to mainstream school when the child's health permits. This includes:
- 19. Advice and support to schools to enable them to support children with medical needs in their current educational environment.
- 20. The Council will work alongside the current SEIP (Secondary Education Inclusion Partnership) Surgery provision to enable support to be accessed locally, specifically to support children with social, emotional and mental health needs.
- 21. High Needs Placement's arise where children are required to attend specialist medical educational placement as a result of their high-level medical needs.
- 22. This Policy is intended to achieve the following objectives:

a. To make arrangements for a fair and reasonable amount of available public resources to be allocated to the organisation which incurs costs associated with educational provision for children with medical needs. – *i.e. to ensure that funding follows the demand.* 

b. To encourage schools and the Council to better work together to ensure good quality educational provision can be provided to children with medical needs.

c. To improve advice available to schools with a view to increasing the capacity of schools to help support children with medical needs in order to maintain the continuity of their education.

d. To provide better access to support for schools including services such as Mental Health Well-being Practitioners, Secondary Education Inclusion Partnerships, Health, etc., understanding statutory requirements, duties and responsibilities.

e. To ensure that fewer children will experience long periods out of the school environment without the benefit of educational provision.

f. To make more effective use of available resources, the risk of 'double funding' will be reduced or eliminated.

g. To enable a more affordable and sustainable model of delivery able to meet any future increase in demand for provision.

h. To align the practice of Leicestershire County Council with its neighbouring authorities in recouping pupil funding in order to manage the increased demand within the authority.

#### 8. Details of the Recoupment Arrangements

- 23. The method of recovery applies to a standard recoupment cost per day banded to primary and secondary schools, applicable from the first day of provision.
- 24. The recoupment cost will be set out at the beginning of each financial year based on the Leicestershire School funding formula.
- 25. For 2018/19 the rates to be applied for each day the pupil is out of school, and with effect from 1st January 2019 are:
  - Primary £16.90 per day
  - Key stage 3 £23.77 per day
  - Key stage 4 £26.99 per day
- 26. Schools will be invoiced in arrears on a termly basis.
- 27. The application of a standard recoupment cost to primary and secondary will ensure that no particular school is disadvantaged particularly where there might be a high cost placement, for example when commissioned by the NHS, or where a child may be out of school for an extended period.
- 28. The Council will review the recoupment cost on an annual basis but reserves the right to increase the recoupment where the costs to the Council have been increased before the next annual review is scheduled.

# 9. Support for which the Council will not charge

- 29. It is not intended to recoup the cost of support offered directly by the Council's Advice Line or CMN practitioners.
