1. To impose a 30 mph Speed Limit on part of Leicester Road, Ashby de la Zouch

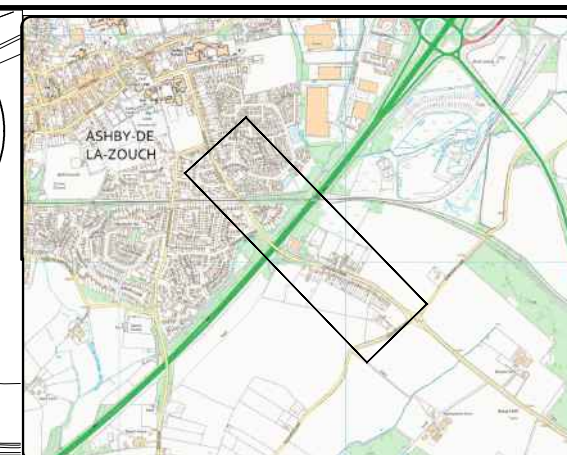
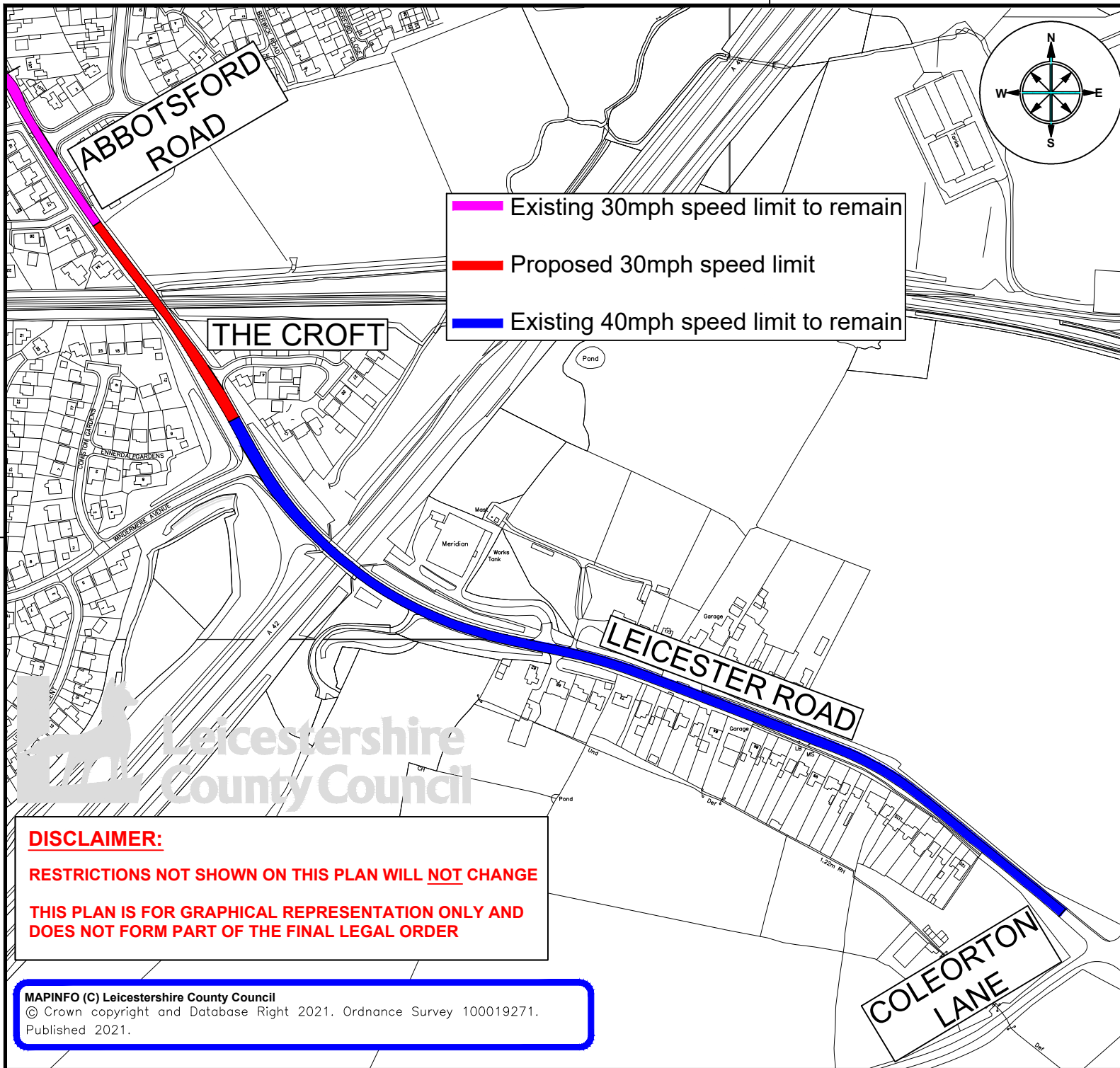

STATEMENT OF REASONS

Leicestershire County Council proposes to make the following order.

On behalf of the developer David Wilson Homes it is necessary to extend the existing 30mph speed limit along part of Leicester Road, Ashby De La Zouch. The 30mph speed limit will be extended south of the site frontage. The extension will provide a safe highway environment and safe egress for the development.

This order will see the extension of 30mph speed limit on the following street; Leicester Road, Ashby De La Zouch.

1. This Order may be cited as "The Leicestershire County Council (Leicester Road, Ashby de la Zouch) (Imposition of 30mph Speed Limit) Order 202 "

2. The Order shall come into force on the day of 2021

3. The Order referred to in Schedule 1 is hereby revoked in full

4. No person shall drive any motor vehicle at a speed exceeding 30 MPH on the length of road as specified in Schedule 2 to this Order.

The Leicestershire County Council ("the Council") in exercise of its powers under Sections 84(1) and (2) of, and Part IV of Schedule 9 to, the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the chief officer of police in accordance with Part III of Schedule 9 to the Act, hereby makes the following Order:-

1. Schedule 2 of "The Leicestershire County Council (Various Roads, Ashby de la Zouch) (De-Restriction, Imposition of 50 mph, 40 mph and 30 mph Speed Limits and Revocation of 40 mph Speed Limit) Order 1995" is hereby revoked.
2. No person shall drive any motor vehicle at a speed exceeding 40 miles per hour on the length of road specified in the Schedule to this Order.
3. This Order may be cited as "The Leicestershire County Council (Leicester Road (Part) Ashby De La Zouch) (Revocation of 50 mph and Imposition of 40 mph Speed Limit) Order 2000", and shall come into force on the *4th* day of *September* 2000.

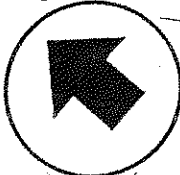
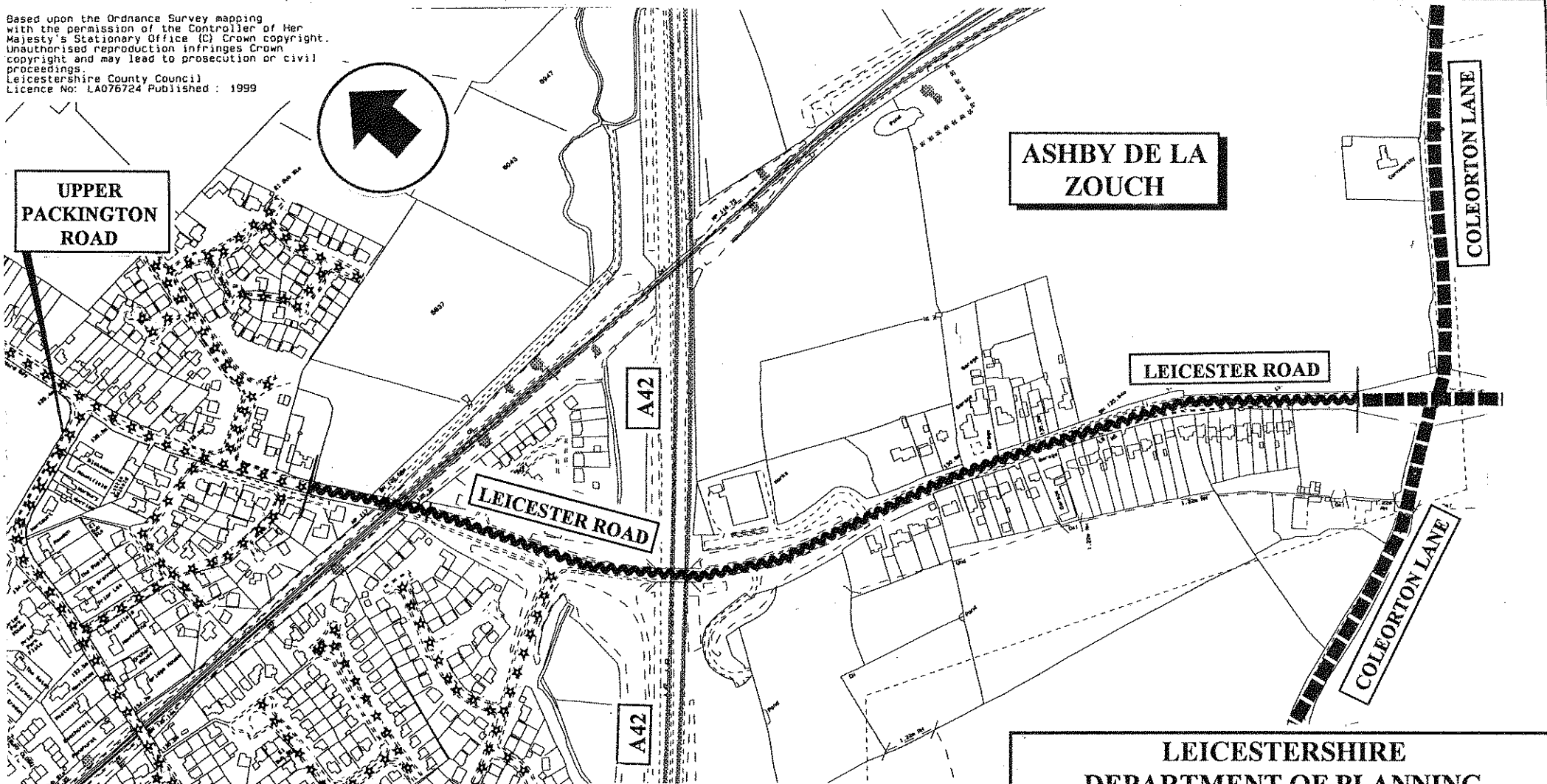
