THE LEICESTERSHIRE COUNTY COUNCIL hereby gives notice that it proposes to make an Order under Sections 1, 2, 4, 5, 32, 35, 45, 46, 47, 49 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act"), and of all other enabling powers, and after consultation with the Chief Officer in accordance with Part III of Schedule 9 of the Act, the effect of which will be to impose -

1. Limited waiting 1 hour no return for 1-hour Mon – Sat 8am – 6pm – Bedford Square, Cattlemarket, Devonshire Square and Wards End, Loughborough
2. Disabled Parking 3 hours no return for 1 hour – Cattlemarket and Wards End, Loughborough
3. Loading Only 6am – 6pm – Devonshire Square and Wards End, Loughborough
4. Restricted Parking Zone (no waiting and no loading at any time - Cattlemarket, Devonshire Square and Devonshire Lane, Loughborough
5. Pedestrian & Cycle Zone (except for loading midnight – 10am and 4pm – midnight) – Devonshire Square, Loughborough
6. No waiting at any time / No loading Mon-Sat 7.30am-9am and 4.30pm-6pm – Southfield Road, Loughborough

THE LEICESTERSHIRE COUNTY COUNCIL hereby gives notice that it proposes to make an Order under Sections 5 and 84 of the Road Traffic Regulation Act 1984 ("the Act"), and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, the effect of which will be:

1. To impose a 20mph speed limit on Wards End/Cattle Market, Loughborough.





PROPOSED 20MPH SPEED LIMIT
STATEMENT OF REASONS

Leicestershire County Council (LCC) is proposing to lower the speed limit on Wards End/ Cattle Market, Loughborough from 30mph to 20mph.

This new speed limit of 20mph coincides with a proposed parking restricted area in this vicinity due to developer highway alterations.

This scheme is being introduced on the grounds of road safety.

The Leicestershire County Council (“the Council”) in exercise of its powers under Sections 5 and 84 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (“the Act”) and of all other enabling powers and after consultation with the chief officer of police in accordance with Part III of Schedule 9 to the Act, hereby makes the following Order:-

1. This Order may be cited as “The Leicestershire County Council (Wards

End/Cattle Market, Loughborough) (Borough of Charnwood) (Imposition of

20 mph Speed Limit) Order 202”
2. The order shall come into force on the xx day of xxxxx 202.
3. No person shall drive any motor vehicle at a speed exceeding 20 miles per

hour on the roads specified in the Schedule to this order.
