  - 2. The Order shall come into force on the fourteenth day of June 2021
  - 3. The Leicestershire County (B676 Melton Road, Burton on the Wolds and Six Hills Lane, Broughton and Old Dalby in the Boroughs of Charnwood and Melton) (Impositions of 50mph speed limit) Order 2020 is hereby revoked in Part as specified in Schedule 1 to this Order

- No person shall drive any motor vehicle at a speed exceeding 50 MPH on the lengths of roads as specified in Schedule 2 to this Order

From a point 265 metres south-east of its junction with New Lane, Walton on the Wolds to a point 100 metres west of its junction with Green Lane, Seagrave

### Seagrave Road, Sileby

From its junction with Big Lane, Seagrave to a point 95 metres west of its junction with Big Lane, Seagrave

# Berrycott Lane, Seagrave

From its junction with Paudy Lane to a point 30 metres south-west of its junction with Paudy Lane
