

**Map of Path:** Route applied for is shown in RED DASHES starting at Humbles Farm on Blackberry Lane, Cossington goes north east and ends at the Ratcliffe Road, Cossington. The route is shown as an ORPA on OS Maps, is named as Blackberry Lane and is not on the online Definitive Map. The route is on the list of streets but is not a tarmac road and therefore an application for a BOAT is deemed necessary.
