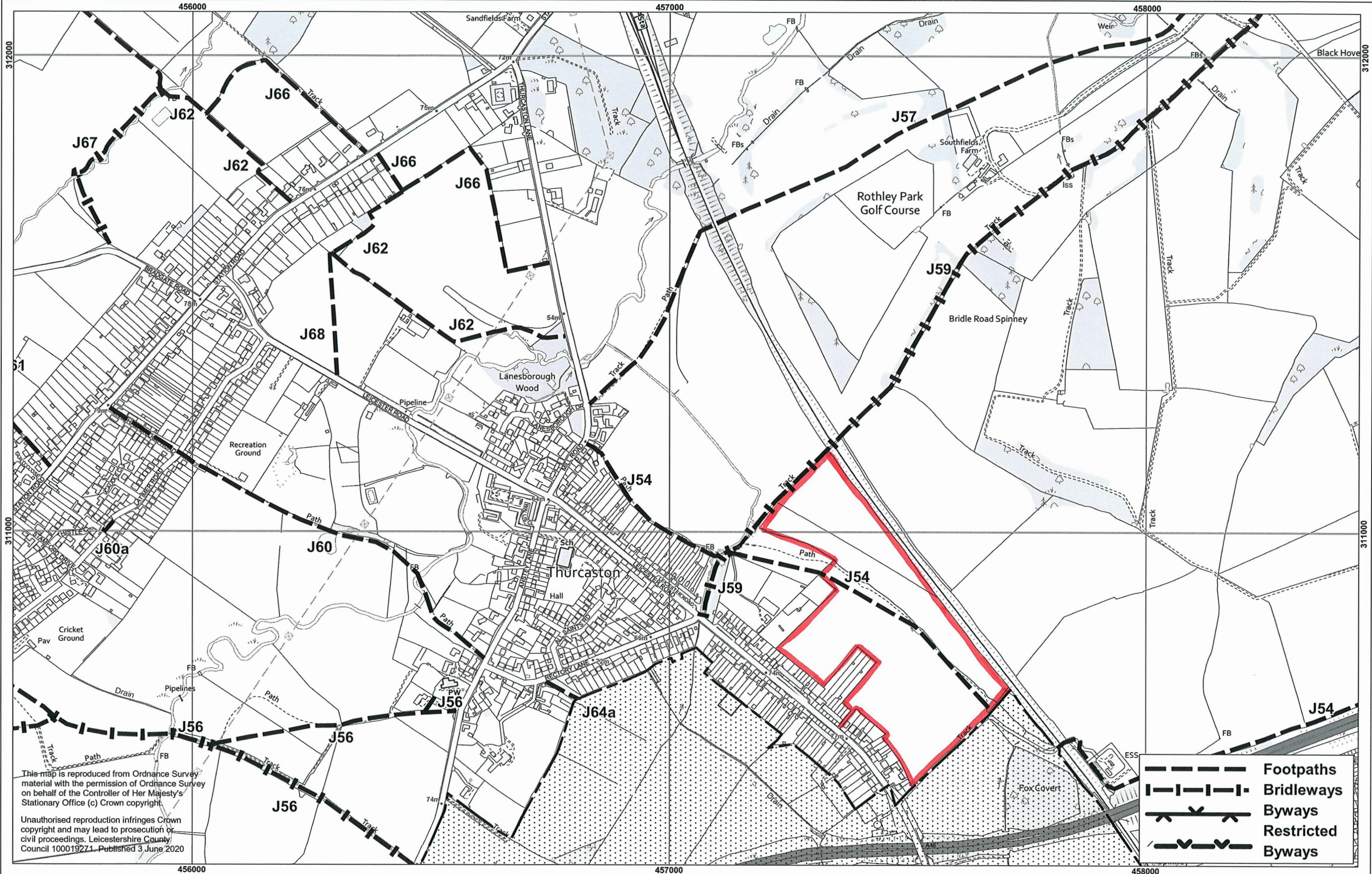


Extract From The Definitive Map of Public Rights of Way for Leicestershire
